

CORNER OF LOT NO. 2336 OF SAID WESTFIELD SQUARE, BLOCKS 1A & 2; THENCE N 0' 06' 42" W, 151.75 FEET TO AN IRON PIN SET; THENCE WESTERLY ON A CURVE TO THE RIGHT HAVING A RADIUS OF 602.96 FEET, AN ARC LENGTH OF 34.26 FEET AND A CHORD LENGTH OF 34.25 FEET BEARING N 84 06 53 W TO AN IRON PIN SET: THENCE N 0° 06' 42" W, 239.67 FEET TO AN IRON PIN SET AND PASSING THROUGH AN IRON PIN SET AT 60.59 FEET; THENCE N 89' 53' 18" E, 160.00 FEET TO AN IRON PIN SET AND PASSING THROUGH AN IRON PIN SET AT 130.00 FEET; THENCE S 86° 38' 36" E, 495.91 FEET TO AN IRON PIN SET AND PASSING THROUGH AN IRON PIN SET AT 30.06 FEET; THENCE N 89' 53' 18" E, 224.06 FEET TO AN IRON PIN SET AND PASSING THROUGH THE LINE COMMON TO SAID NORTHWEST AND NORTHEAST QUARTERS AT 140.94 FEET; THENCE SO' 06' 42" E, 65.00' TO AN IRON PIN FOUND IN THE NORTHWEST CORNER OF LOT NO. 2313 OF WESTFIELD SQUARE, BLOCKS 1A & 2; THENCE CONTINUING S 0° 06' 42" E, 300.00 FEET ALONG THE WEST LINE OF LOT NOS. 2313 & 2314 OF WESTFIELD SQUARE BLOCKS 1A & 2 TO AN IRON PIN FOUND, SAID IRON PIN BEING THE SOUTHWEST CORNER OF SAID LOT NO. 2314 AND IN THE NORTH LINE OF LOT NO. 2316 OF WESTFIELD SQUARE, BLOCKS 1A & 2: THENCE S 89° 53' 18" W, 845.00 FEET ALONG A NORTH LINE OF WESTFIELD SQUARE, BLOCKS 1A AND 2 AND PASSING THROUGH SAID LINE COMMON TO THE NORTHEAST AND NORTHWEST QUARTERS AT 93.11 FEET TO THE PLACE OF BEGINNING AND CONTAINING 7.527 ACRES, MORE OR LESS, OF WHICH 0.739 ACRES LIES IN SAID NORTHEAST QUARTER AND 6.788 ACRES LIES IN SAID NORTHWEST QUARTER, BUT SUBJECT TO ALL LEGAL HIGHWAYS AND EASEMENTS OF RECORD.
