

## LEGAL DESCRIPTION

Situated in the Township of Madison, County of Richland, State of Ohio, and also known as being part of the Northwest Quarter of Section 23, Township 21, Range 18, and further bounded and described as follows:

Commencing at point in the centerline of the Mansfield-Ashland Road, U.S.42, said point being the intersection of the north line of said Quarter and the centerline of U.S.42;

Thence South 53°35'00" West along said centerline, 24.31 feet to an intersection with the west line of Terrace Drive;

Thence South 1°26'00" West, along the west line of Terrace Drive, 376.26 feet;

Thence South 45°05'00" West, 104.69 feet to a 5/8" rebar found:

Thence North 44°55'00" West, 250.00 feet to the right-of-way line of U.S.42 and a P.K.

Thence South 45°05'00" West, along said right-of-way line, 20.00 feet to a 5/8" rebar with ID cap found and the "TRUE PLACE OF BEGINNING" of the parcel herein described;

Thence South 44°55'00" East, 194.00 feet to a point;

Thence South 01°26'00" West, 49.26 feet to a 5/8" rebar found and used;

Thence South 45°05'00" West, 77.07 feet to a point in the northeast line of a record 0.439 acre parcel now or formerly owned by K. Paul Gordon as recorded in Volume 43 Page 75 of Richland County records;

Thence North 44°55'00" West along the northeast line of the aforesaid Gordon parcel a distance of 228.00 feet to the southeasterly right of way of U.S.42 and a drill hole found;

Thence North 45°05'00" East along the southeasterly right of way of U.S.42, 112.71 feet to the "TRUE PLACE OF BEGINNING" and containing 0.5760 acres (25093 sq. ft.) of land, more or less, as calculated by the above courses by Steven W. Clutter, Ohio Registered Surveyor No.S-7655, for and on behalf of Bock & Clark under project no.96083, subject to all legal highways and easements of record.
