THENCE SOUTHEASTERLY ALONG A CURVE TO THE LEFT, ALONG THE CENTERLINE OF MILL RUN ROAD (T.H. 130), HAVING A RADIUS OF 501.80 FEET, AN ARC LENGTH OF 20.39 FEET, A CHORD LENGTH OF 20.39 FEET AND A CHORD BEARING SOUTH 29°42'31" EAST TO A SURVEY SPIKE WITH "SURVEY MARKER" EMBOSSED AND WASHER STAMPED "SEILER 6869" FOUND AT THE NORTHWEST CORNER OF LANDS NOW OR FORMERLY OWNED BY CHARLES F. AND BARBARA J. LOGAN, AS RECORDED IN OFFICIAL RECORDS VOLUME 141, PAGE 544;

THENCE SOUTH 69°17'08" WEST, ALONG THE NORTH LINE OF SAID LOGAN LANDS, PASSING THROUGH A SURVEY MARKER FOUND WITH CAP STAMPED "SEILER 6869" AT 20.54, FEET A TOTAL DISTANCE OF 135.34 FEET TO A SURVEY MARKER FOUND WITH CAP STAMPED "SEILER 6869":


