

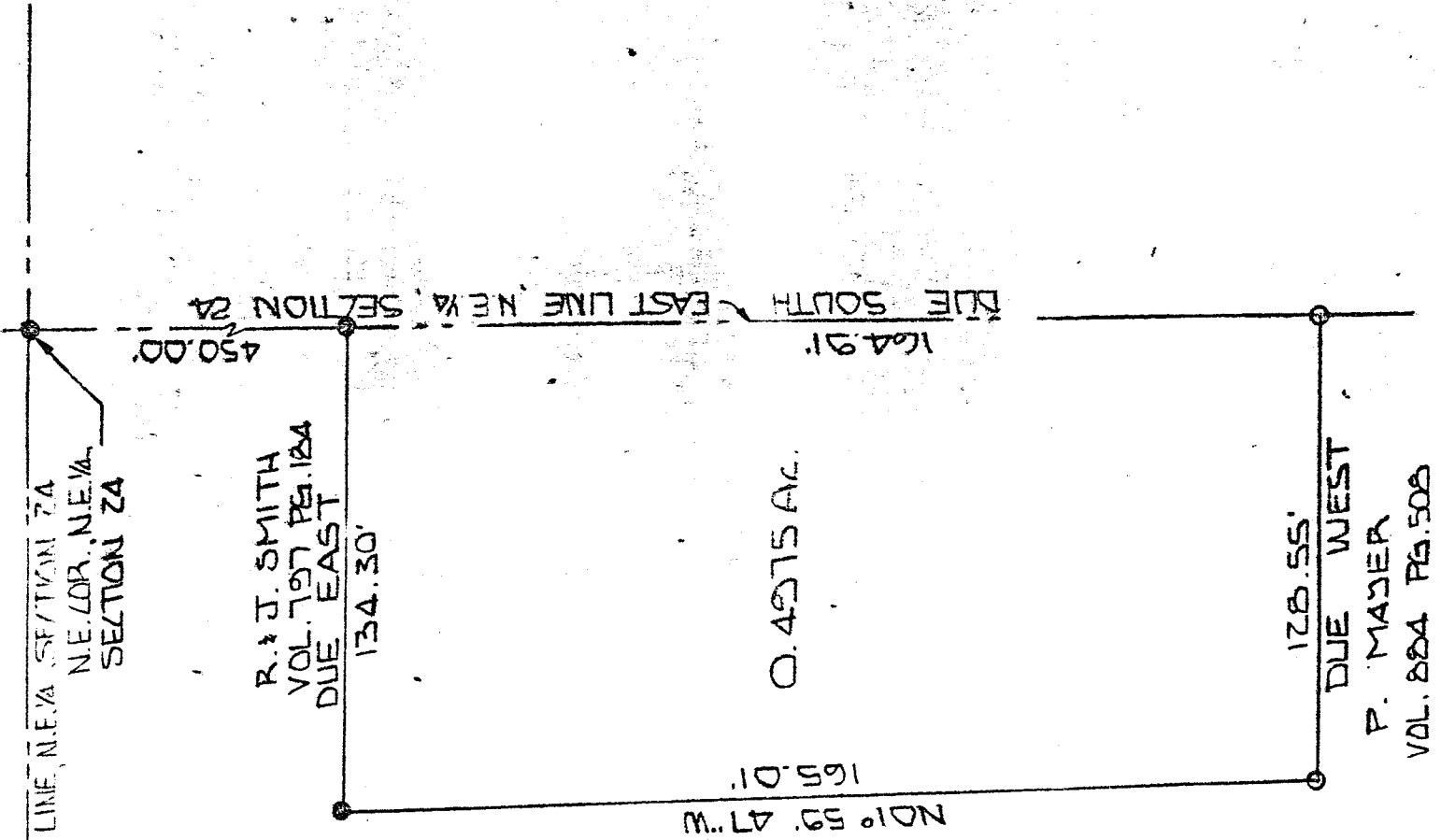
PLAT OF SURVEY FOR J. L. SMITH

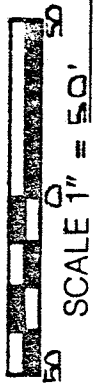
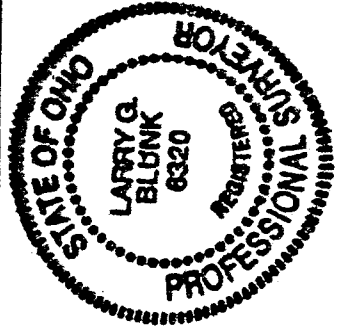

Located in the Township of Madison, County of Richland, State of Ohio and being a part of the Northeast Quarter of Section 24, Township 21, Range 19 and more particularly described as follows:

Beginning at an iron pin found in the Northeast Corner of the Northeast Quarter of Section 24.
Thence Due South along the east line of the Northeast Quarter of Section 24 a distance of 450.00 feet to an iron pin found and the True Place of Beginning.
Thence continuing Due South along the east line of the Northeast Quarter of Section 24 a distance of 164.91 feet to an iron pin set.

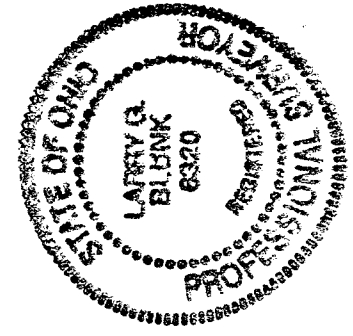
Thence Due West a distance of 128.55 feet to an iron pin set.

Thence N 01 degrees 59' 47" W a distance of 165.01 feet to an iron pin found.
