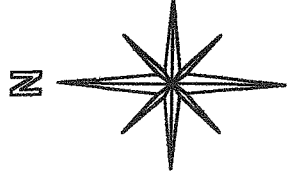
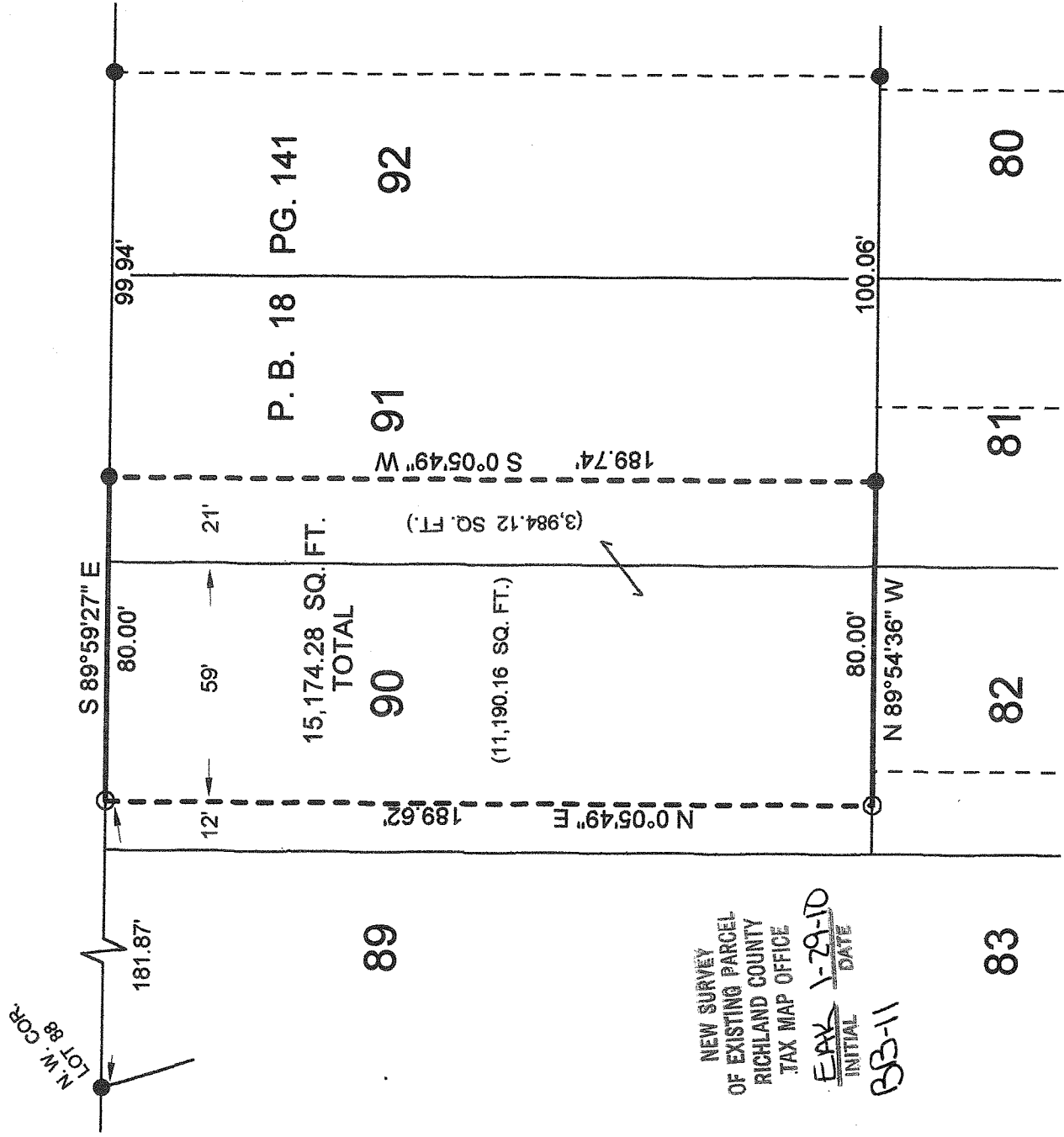


GREEN RIDGE ALLOT. #2

 RICHLAND COUNTY, OHIO

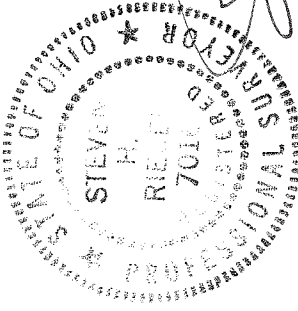

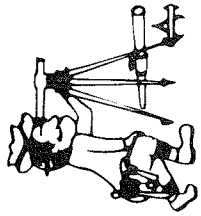

Situated in the Township of Madison, County of Richland, State of Ohio and being part of the Northwest quarter of Section 25, Township 21N, Range 18W, being known as part of Lot 90 and part of Lot 91 of Green Ridge Allotment Number 2 as recorded in Plat book 18 page 141 and being more fully described as follows:

Commencing at an existing iron pipe at the Northwest corner of Lot 88, thence running South 89 deg. 59 min. 27 sec. East along the South line of Bonnie Drive for 181.87 feet to a 5/8 inch rebar set and the place of beginning;

thence continuing South 89 deg. 59 min. 27 sec. East along said South line (also being the North line of Lots 90 and 91) for 80.00 feet to an existing iron pipe;

thence turning and running South 00 deg. 05 min. 49 sec. West for 189.74 feet to an existing iron pipe on the South line of Lot 91;

thence turning and running North 89 deg. 54 min. 36 sec. West along the South line of Lots 91 and 90 for 80.00 feet to a 5/8 inch rebar set;

thence turning and running North 00 deg. 05 min. 49 sec. East for 189.62 feet to the place of beginning.

The above described parcel has a calculated area of 15,174.28 square feet of land (11,190.16 square feet being in Lot 90 and 3,984.12 square feet being in Lot 91) according to a survey made on January 20, 2010 by Steven H. Riedel, Ohio surveyor 7016.

All 5/8 inch rebars set have a plastic cap stamped "PS 7016".
