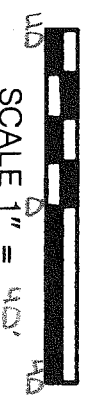
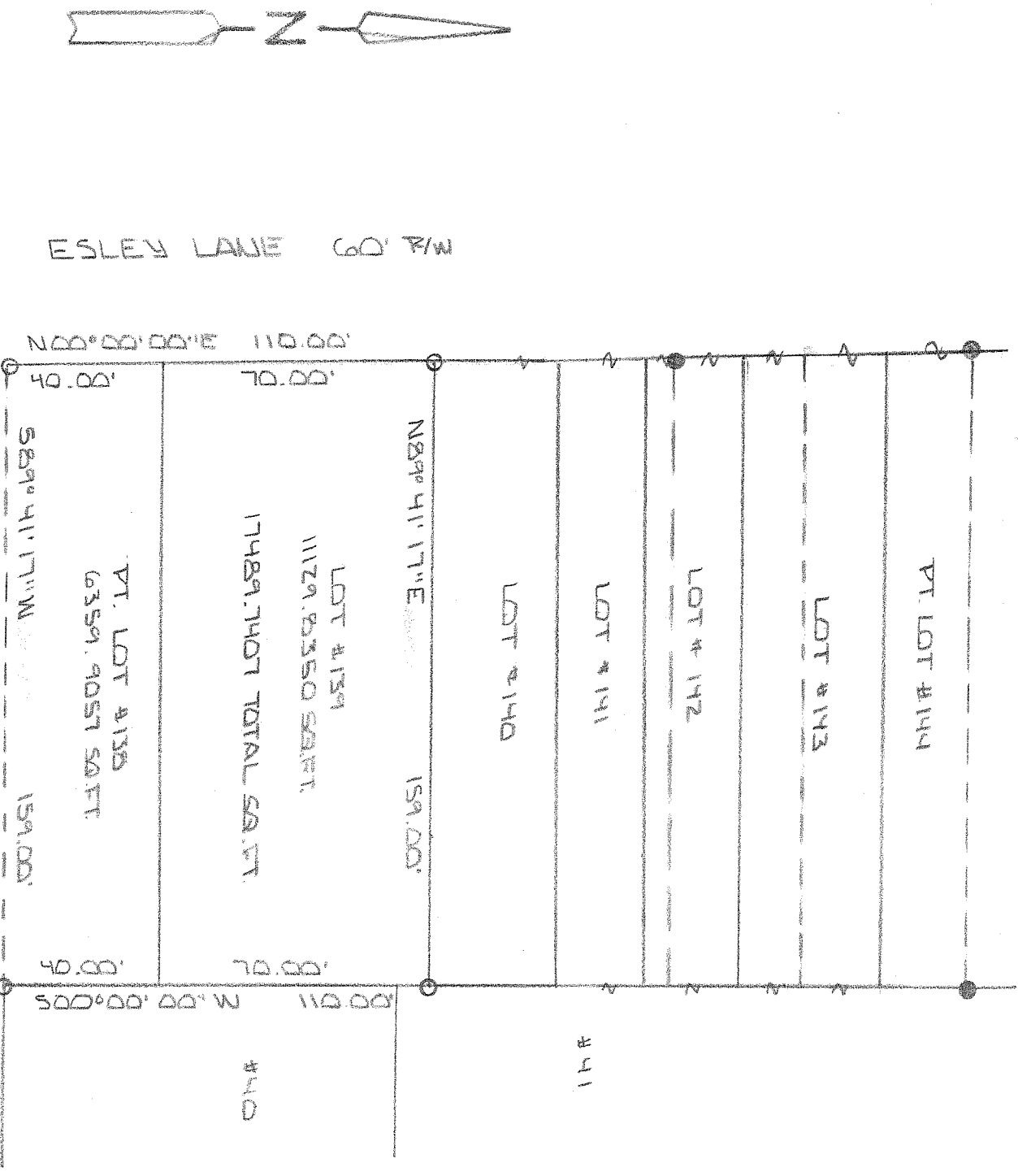

 QUARTER NE KUALANDA COUNTY, OHIO

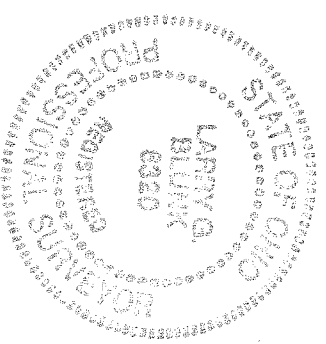

FOR

Located in the Township of Madison, County of Richland, State of Ohio and being Lot Number 139 and a part of Lot Number 138 of Harporest Heights and Peach Orchard Allotment and more particularly described as follows:

Beginning at an iron pin set in the Northwest Corner of Lot Number 139.

Thence N 89 degrees 41' 17" W along the north line of Lot Number 139 a distance of 159.00 feet to an iron pin set in the Northeast Corner of Lot Number 139.

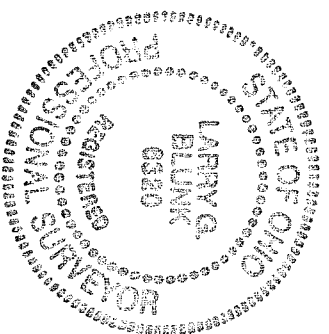
Thence S 00 degrees 00' 00" W along the east line of Lot Numbers 139 and 138 a distance of 110.00 feet to an iron pin set.

Thence S 89 degrees 41' 17" W a distance of 159.00 feet to an iron pin set on the west line of Lot Number 138.

Thence N 00 degrees 00' 00" E along the west line of Lot Numbers 138 and 139 a distance of 110.00 feet to the place of beginning and containing 17489.7407 square feet in all of which 11129.8350 square feet are in Lot Number 139 and 6359.9057 square feet are in a part of Lot Number 138 but subject to all legal highways also all easements of record.
