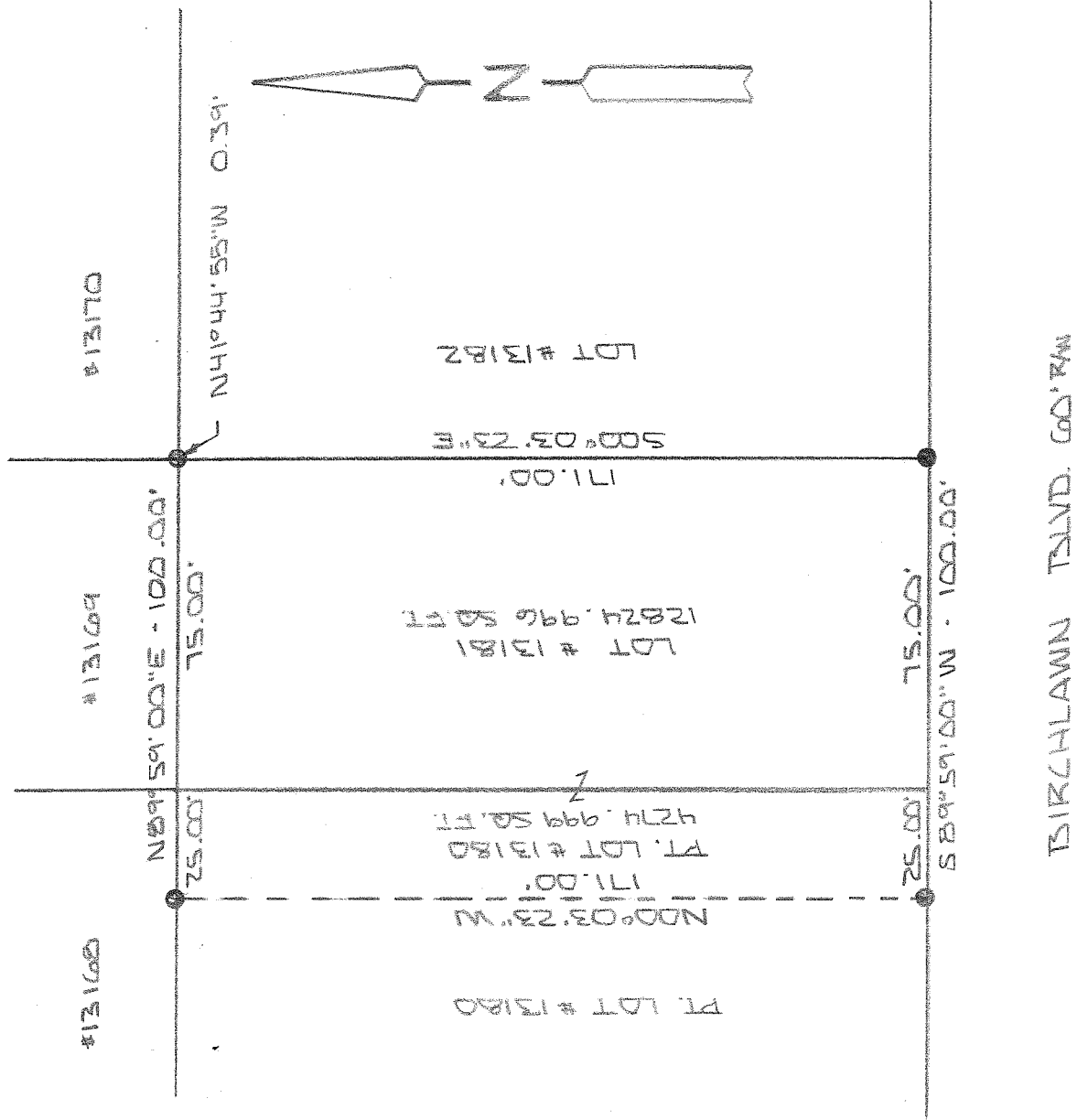


PLAT OF SURVEY FOR BRIAN CONNOR

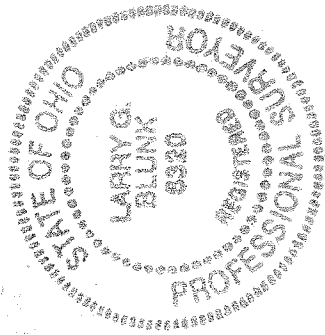

Located in the City of Mansfield, County of Richland, State of Ohio and being all of Lot Number 13181 and a part of Lot Number 13180 and more particularly described as follows:

Beginning at an iron pin fund in the Southeast Corner of Lot Number 13181.

Thence S 89 degrees 59' 00" W along the south line of Lot Numbers 13181 and 13180 a distance of 100.00 feet to an iron pin found.

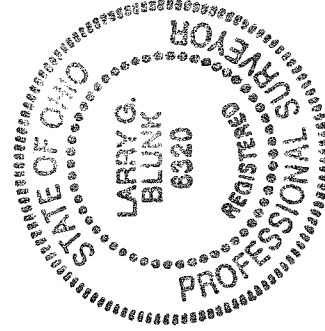
Thence N 00 degrees 03' 23" W a distance of 171.00 feet to an iron pin found on the north line of Lot Number 13180.

Thence N 89 degrees 59' 00" E along the north line of Lot Numbers 13180 and 13181 a distance of 100.00 feet to the Northeast Corner of Lot Number 13181, referenced by an iron pin found N 41 degrees 44' 55" W - 0.39 feet.

Thence S 00 degrees 03' 23" E along the east line of Lot Number 13181 a distance of 171.00 feet to the place of beginning and containing 17099.995 square feet in all of which 4274.999 square feet are in a part of Lot Number 13180 and 12824.996 square feet are in Lot Number 13181 but subject to all legal highways also all easements of record.

Basis of Bearings: Bearings are to an assumed azimuth and are used to denote angles only.
