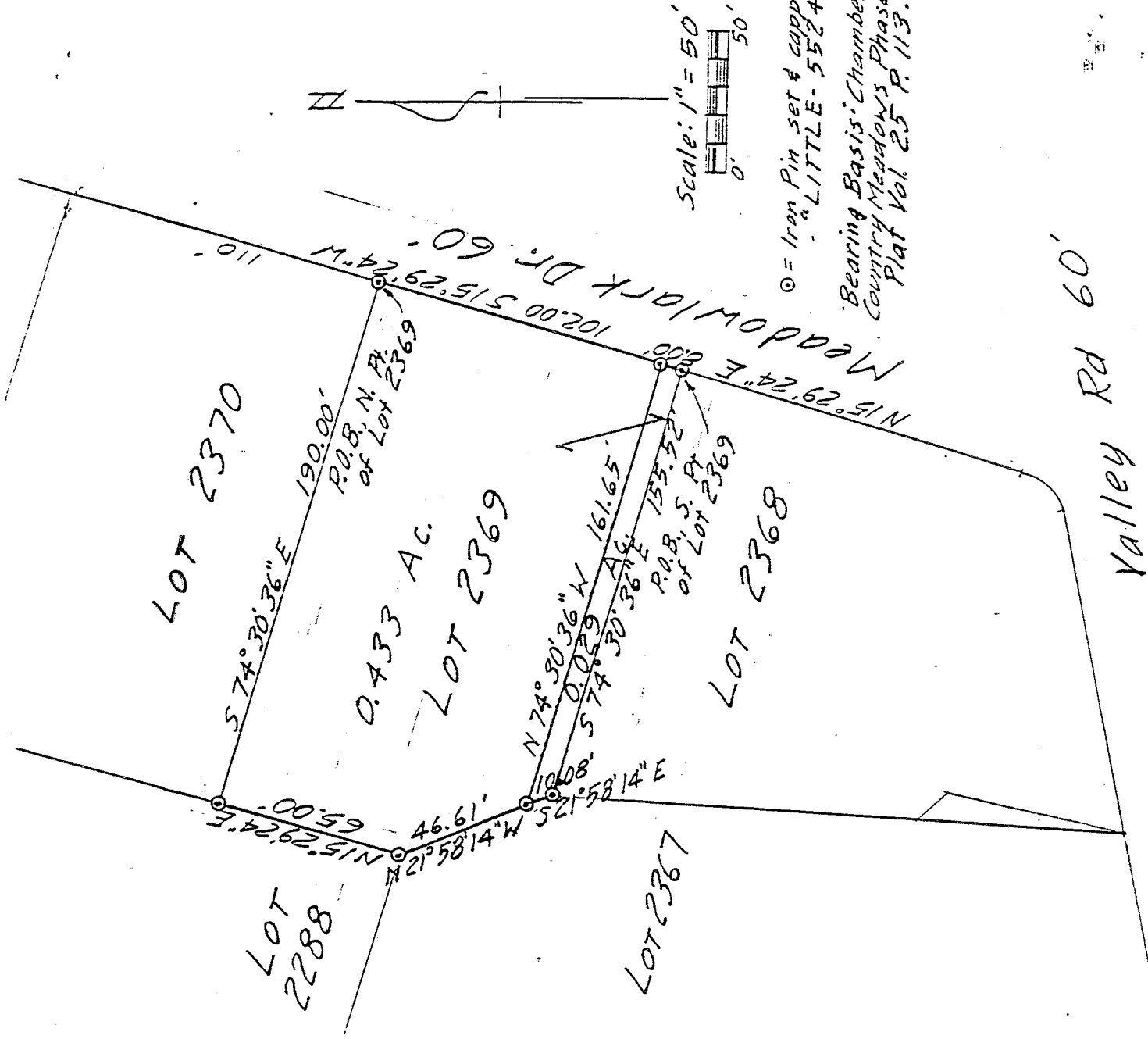

Beginning at an iron pin, set and capped, marking the southeast corner of said Lot 2369, being also the northeast corner of Lot 2368, being also a point on the westerly right-of-way line of Meadowlark Drive;

Thence North 15° 29' 24" East a distance of 8.00 feet to an iron pin, set and capped, said course being with said right-of-way line;

Thence North 74° 30' 36" West a distance of 161.65 feet to an iron pin, set and capped, in the westerly line of said Lot 2369;

Thence South 21° 58' 14" East a distance of 10.08 feet to an iron pin, set and capped, marking an exterior corner of said lot;

Thence South 74° 30' 36" East a distance of 155.52 feet to the point of beginning;

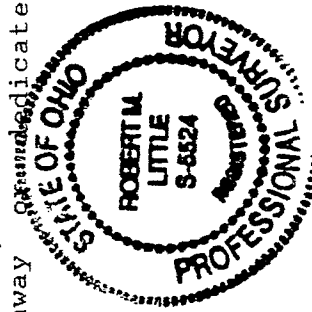

Thence North 21° 58' 14" West a distance of 46.61 feet to an iron pin, set and capped, marking an exterior corner of said lot;

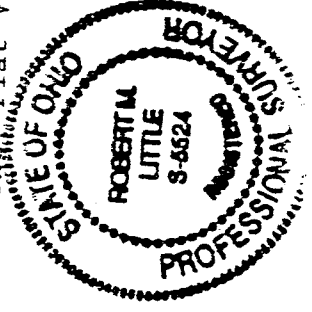
Thence North 15° 29' 24" East a distance of 65.00 feet to an iron pin, set and capped, marking an exterior corner of said lot;
