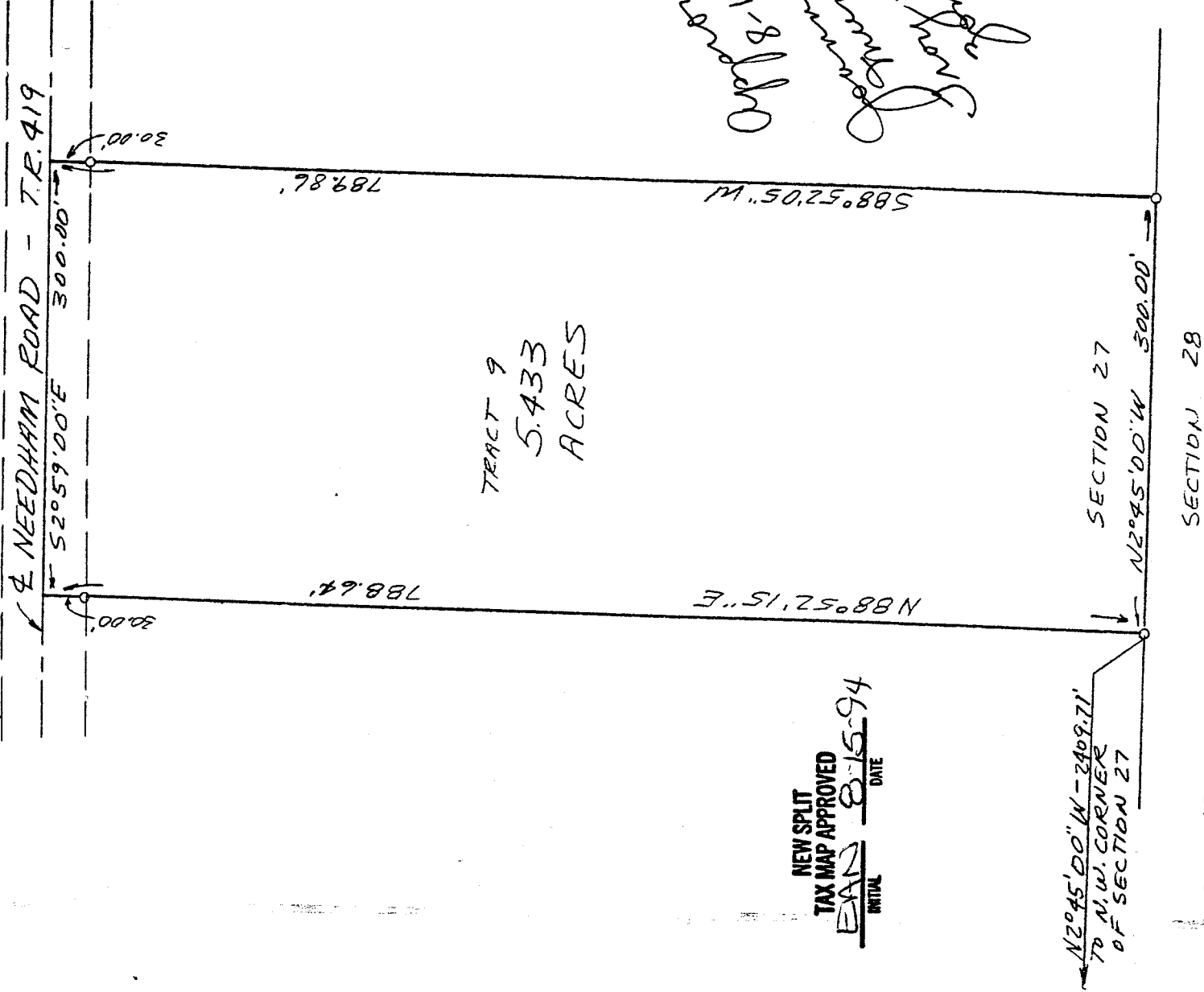

DESCRIPTION - 5.433 ACRE TRACT

Being situated in the northwest quarter of Section twenty-seven (27), Range nineteen (19), Township twenty (20), Congress Lands, Troy Township, Richland County, State of Ohio and being part of that land of record in Official Records Volume , Page in the Richland County Recorder's Office and being more particularly described as follows;

Beginning for reference at a RR Spike found in the centerline intersection of Fox Road with Texter Road, being the northwest corner of Section 27; thence South 02 degrees 45 minutes 00 seconds East along the west line of Section 27 a distance of 2409.71 feet to a 3/4 inch iron pipe set and being the true place of beginning;

thence from the true place of beginning North 88 degrees 52 minutes 15 seconds East a distance of 788.64 feet (passing over a 3/4 inch iron pipe set at 758.64 feet) to a pk nail set in the centerline of Needham Road (Township Road 419);

thence South 02 degrees 59 minutes 00 seconds East along the centerline of Needham Road a distance of 300.00 feet to a pk nail set;

thence South 88 degrees 52 minutes 05 seconds West a distance of 789.86 feet (passing over a 3/4 inch iron pipe set at 30.00 feet) to a 3/4 inch iron pipe set on the west line of Section 27;

thence North 02 degrees 45 minutes 00 seconds West along the west line of Section 27 a distance of 300.00 feet to the place of beginning - containing 5.433 acres, more or less.

Subject to all legal right-of-way of previous record.

The above description was prepared from a survey made by me, Samuel W. Vance, Registered Surveyor No. 6553 in July, 1994. Bearing Basis assumed. All pipe set are 3/4 inch by 30 inch iron pipe with plastic cap stamped "Vance 6553".
