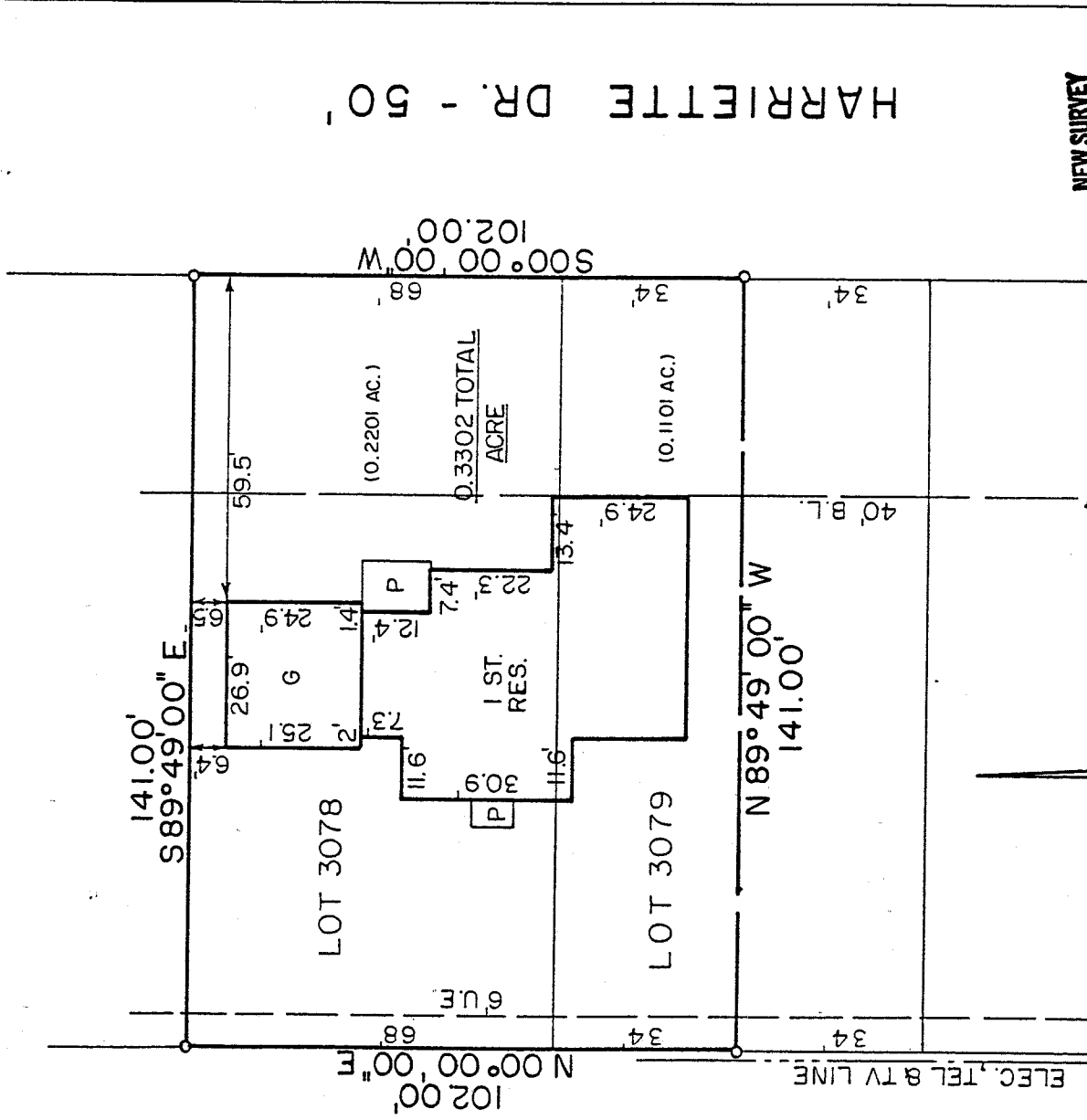

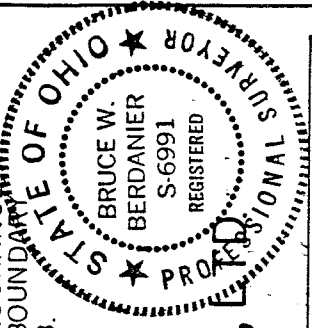
HARRIETTE DR. - 50'

DESCRIPTION: Being a part of Lot 3078 and part of Lot 3079 in Morrisfield No.2, in the City of Shelby, Richland County, Ohio, and being more particularly described as follows;

Beginning for the same at an iron pipe found at the northeast corner of Lot 3078, said point being on the west right-of-way line of Harriette Drive (50 feet in width);

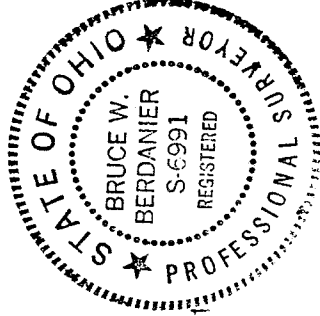
- 1) thence S 00°00'00" W, a distance of 102.00 feet along the east line of Lots 3078 and 3079 and the west right-of-way line of Harriette Drive to an iron pipe found;
- 2) thence N 89°49'00" W, a distance of 141.00 to an iron pipe found on the west line of Lot 3079;
- 3) thence N 00°00'00" E, a distance of 102.00 feet along the west line of Lots 3079 and 3078 to an iron pipe found at the northwest corner of Lot 3078;
- 4) thence S 89°49'00" E, a distance of 141.00 feet along the north line of Lot 3078 to the real point of beginning

and containing 0.3302 acres, more or less, of which 0.2201 acres is in Lot 3078 and 0.1101 acres is in Lot 3079 but subject to all legal easements and public rights-of-way now on record. Bearings are based on Plat Volume 18, Page 125.
