Thence N 04 degrees 26' 50" E passing thru an iron pin set at 25.00 feet a total distance of 300.00 feet to an iron pin set.

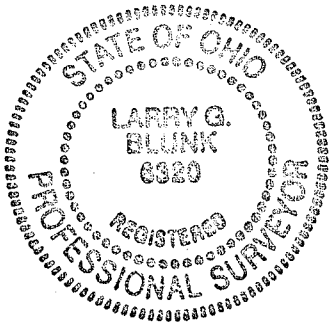
Thence S 90 degrees 00' 00" W a distance of 150.00 feet to an iron pin set.

Thence S 03 degrees 11' 00" W a distance of 319.33 feet to an iron pin found.

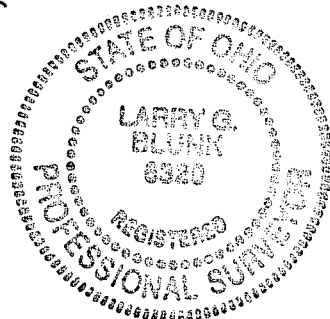
