

Being a part of the Southeast Quarter of Section Thirty One (31), Township Twenty One (21), Range Eighteen (18), Madison Township, Richland County, Ohio and being more particularly described as follows:

Commencing at concrete monument found at the northwest corner of the Southeast Quarter of said Section Thirty One (31);

Thence North $88^{\circ} 58'19''$ East with the north line of the Southeast Quarter of said Section Thirty One (31) a distance of 701.98 feet to a survey marker set at the point of beginning;

Thence North $88^{\circ} 58'19''$ East with the north line of the Southeast Quarter of said Section Thirty One (31) a distance of 1750.00 feet to a survey marker set;

Thence South $00^{\circ}39'57''$ East a distance of 50.00 feet to a survey marker set;

Thence North $88^{\circ}58'19''$ East a distance of 160.00 feet to a survey marker set on the westerly right of way of Trimble Road;

Thence South $0^{\circ}39'57''$ East with the westerly right of way of Trimble Road a distance of 314.78 feet to a railroad spike set;

Thence South $5^{\circ}0'1'51''$ West with the westerly right of way of Trimble Road a distance of 50.38 feet to a railroad spike set;

Thence South $0^{\circ}39'57''$ East with the westerly right of way of Trimble Road a distance of 118.23 feet to a survey marker set;

Thence along a curve to the left with the westerly right of way of Trimble Road said curve having a central angle of $4^{\circ}0'0''36''$, radius of 856.16 feet, an arc length of 59.92 feet, a tangent of 29.97 feet with a chord bearing South $2^{\circ}40'15''$ East a chord length of 59.91 feet to a survey marker set;

Thence South $53^{\circ}24'02''$ West with the westerly right of way line of Trimble Road a distance of 52.51 feet to a survey marker set;

Thence South $28^{\circ}50'37''$ East with the westerly right of way of Trimble Road a distance of 138.48 feet to a survey marker set;

Thence South 89°13'24" West a distance of 259.00 feet to a survey marker set;

Thence South 00°31'01" East a distance of 30.00 feet to a survey marker set;

Thence South 88°58'19" West a distance of 720.00 feet to a survey marker set;

Thence North 01°01'41" West a distance of 45.00 feet to a survey marker set;

Thence North 85°19'16" West a distance of 960.00 feet to a survey marker set;

Thence North 31°26'33" West a distance of 143.34 feet to a survey marker set;

Thence North 58°33'27" East a distance of 128.77 feet to a survey marker set;

Thence along a curve to the right having a central angle of 14°47'18", a radius of 320.00 feet, an arc length of 82.60 feet, a tangent of 41.53 feet, a chord bearing of North 65°57'06" East with a chord length of 82.36 feet to a survey marker set;


Thence North 01°01'41" West a distance of 371.29 feet to the survey marker found at the point of beginning, containing 30.623 acres of land more or less, subject to all highways, easements, and use restriction of record.

This description is based upon an actual field survey. All bearings are based upon the centerline of Trimble Road bearing being North 00°39'57" West as shown on the Ohio Department of Transportation plan for the improvement of Trimble Road.

Survey markers set are 5/8" diameter by 30" long rebar with cap stamped, "Richland Engineering Limited, Robert A. Cunning, R.L.S. 4939".

Bearings are for the determination of angular measurement only.
