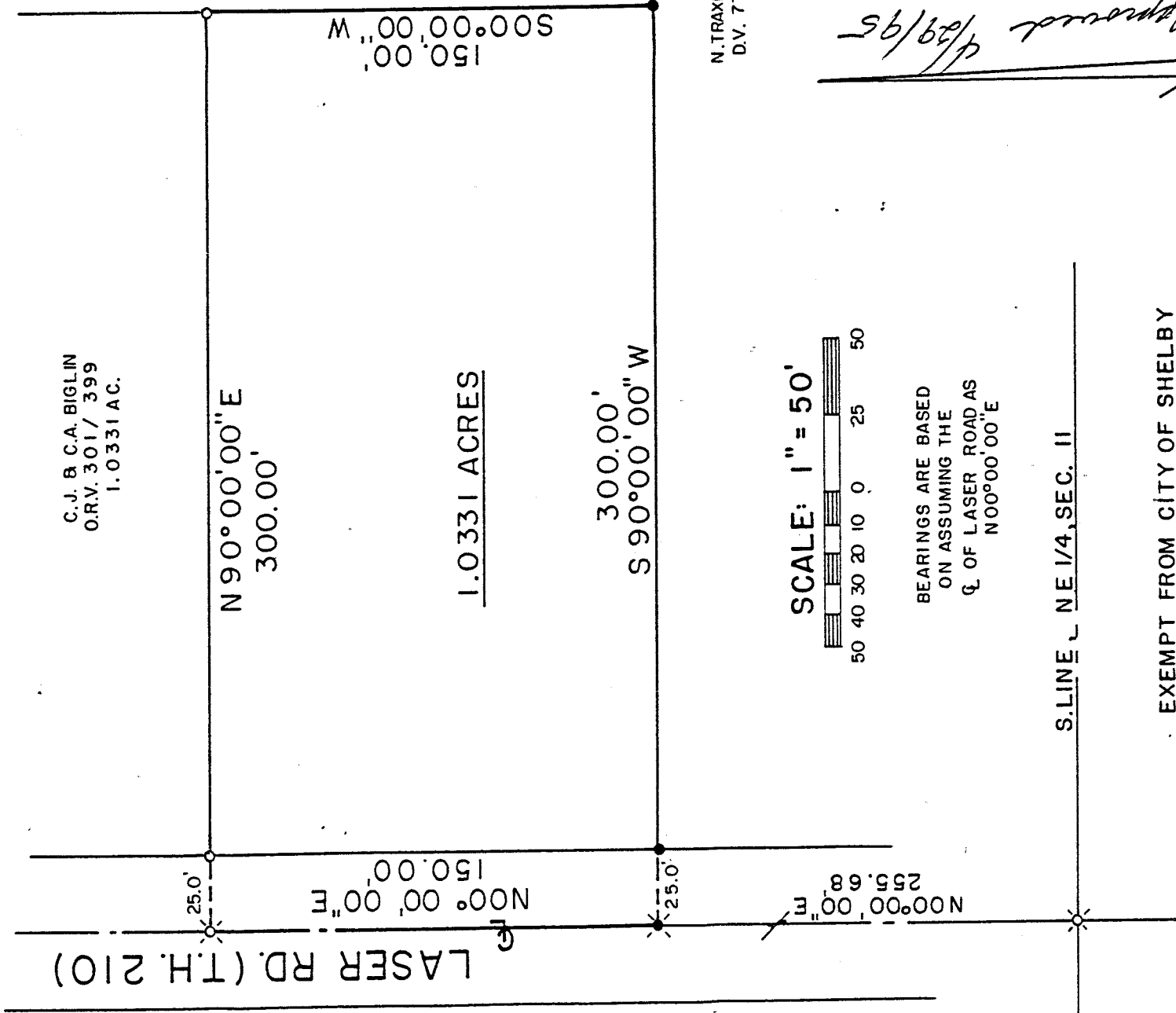


PLAT OF PROPERTY SURVEY

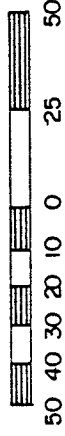

1.0331 ACRES

DESCRIPTION: Being part of the Northeast Quarter, Section 11, Township 22, Range 19, Jackson Township, Richland County, Ohio, and being more particularly described as follows:

Beginning for the same at a railroad spike found at the intersection of the south line of the northeast quarter of section 11, and the centerline of Laser Road (T.H. 210); thence N 0°00'00" E, a distance of 255.68 feet along the centerline of Laser Road to a railroad spike set at the real point of beginning of the parcel herein described;

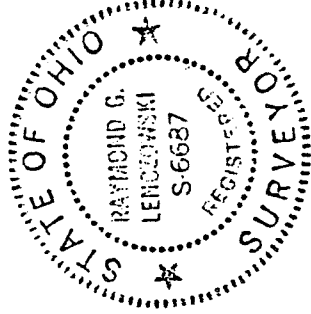
1. thence continuing N 0°00'00" E, a distance of 150.00 feet, along the centerline of Laser Road to a railroad spike found at the southwest corner of a 1.0331 acre parcel described in O.R. Volume 301 Page 399;
2. thence N 90°00'00" E, a distance of 300.00 feet, to an iron pin found at the southeast corner of said 1.0331 acre parcel, passing for reference an iron pin found at 25.00 feet;
3. thence S 0°00'00" W, a distance of 150.00 feet, to an iron pin set;
4. thence S 90°00'00" W, a distance of 300.00 feet, to the point of beginning, and passing for reference an iron pin set at 275.00 feet;

and containing 1.0331 acres, more or less, but subject to all legal easements and public rights of way now on record. All iron pins set are 5/8" diameter with caps stamped "Krocka & Assocs.". Bearings are based on assuming Laser Road as N 0°00'00" E.
