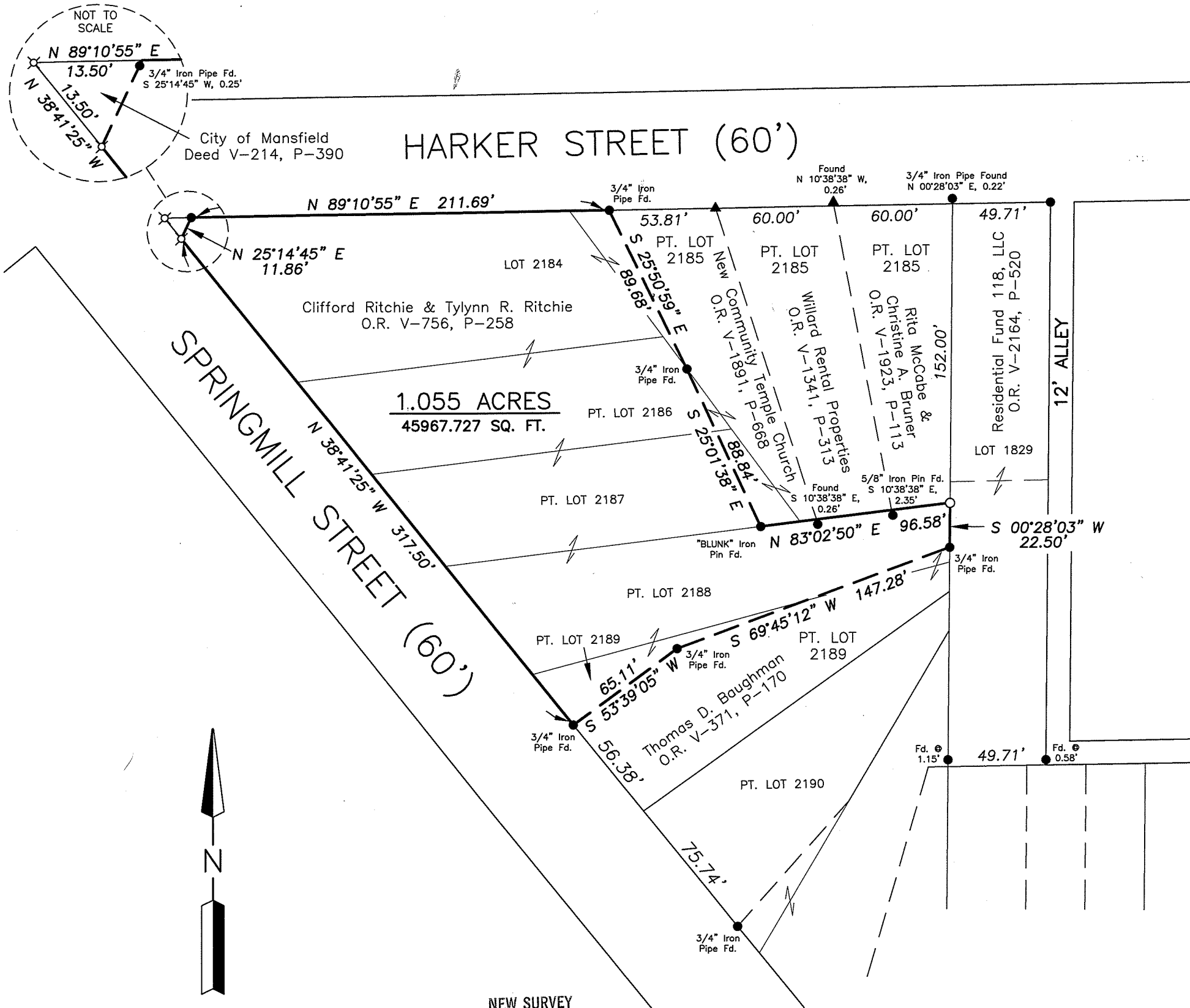
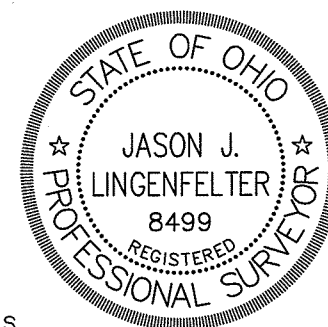

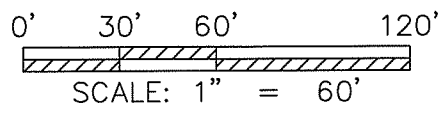


- 5/8" REBAR SET WITH I.D. CAP MARKED SJL INC

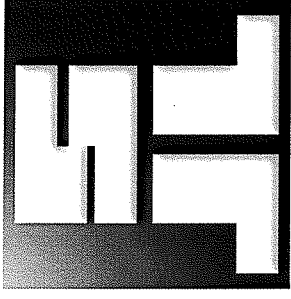

Boundary description of a **1.055** acre, (45967.727 sq. ft.) parcel

Situated in the City of Mansfield, County of Richland, State of Ohio and known as being a part of Lot Numbers 2184, 2185, 2186, 2187, 2188 & 2189 of the consecutively numbered lots in said City of Mansfield, also known as being a part of lands conveyed to Clifford Ritchie & Tylenn R. Ritchie in Official Record Volume 756, Page 258 and further bound and described as follows:

Commencing at a 2 inch MAG nail set at the Northwest Corner of Lot 2184, said point also being the intersection of the south line of Harker Street, (60 foot R/W), and the east line of Springmill Street, (60 foot R/W),

Thence N 89° 10' 55" E, 13.50 feet along the south line of Harker Street and in part the north line of Lot 2184 to a point witnessed by a 3/4 inch iron pipe found S 25° 14' 45" W, 0.25 feet and the True Place of Beginning;

THENCE WITH THE FOLLOWING NINE (9) COURSES:

- 1) **N 89° 10' 55" E, 211.69** feet along the south line of Harker Street and in part the north line of Lots 2184 & 2185 to a 3/4 inch iron pipe found,
- 2) **S 25° 50' 59" E, 89.68** feet across Lot 2185 to a 3/4 inch iron pipe found on the west line of Lot 2185 and the east line of Lot 2186,
- 3) **S 25° 01' 38" E, 88.84** feet across Lots 2186 & 2187 to a 5/8 inch iron bar with ident cap "Blunk" found on the south line of Lot 2187 and the north line of Lot 2188,
- 4) **N 83° 02' 50" E, 96.58** feet along the north line of Lot 2188 and in part the south lines of Lots 2187 & 2185 to a capped iron bar set on the west line of Lot 1829,
- 5) **S 00° 28' 03" W, 22.50** feet along the east line of Lot 2188 and the west line of Lot 1829 to a 3/4 inch iron pipe found,
- 6) **S 69° 45' 12" W, 147.28** feet across Lots 2188 & 2189 to a 3/4 inch iron pipe found,
- 7) **S 53° 39' 05" W, 65.11** feet across Lot 2189 to a 3/4 inch iron pipe found on the east line of Springmill Street,



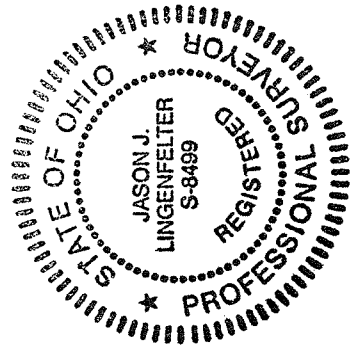
- 8) N 38° 41' 25" W, 317.50 feet along the east line of Springmill Street and in part the west line of Lots 2184, 2186, 22187, 2188 & 2189 to a 2 inch MAG nail set,
- 9) N 25° 14' 45" E, 11.86 feet across Lot 2184 to a point and the true place of beginning and containing within said bounds 1.055 acres, (45967.727 sq. ft.), of land, more or less, and subject to all legal highways and easements of record.

Basis of Bearings: Bearings from Survey "F-2-260".

All iron pins set are 5/8" diameter rod with plastic cap stamped "SJL, INC".
