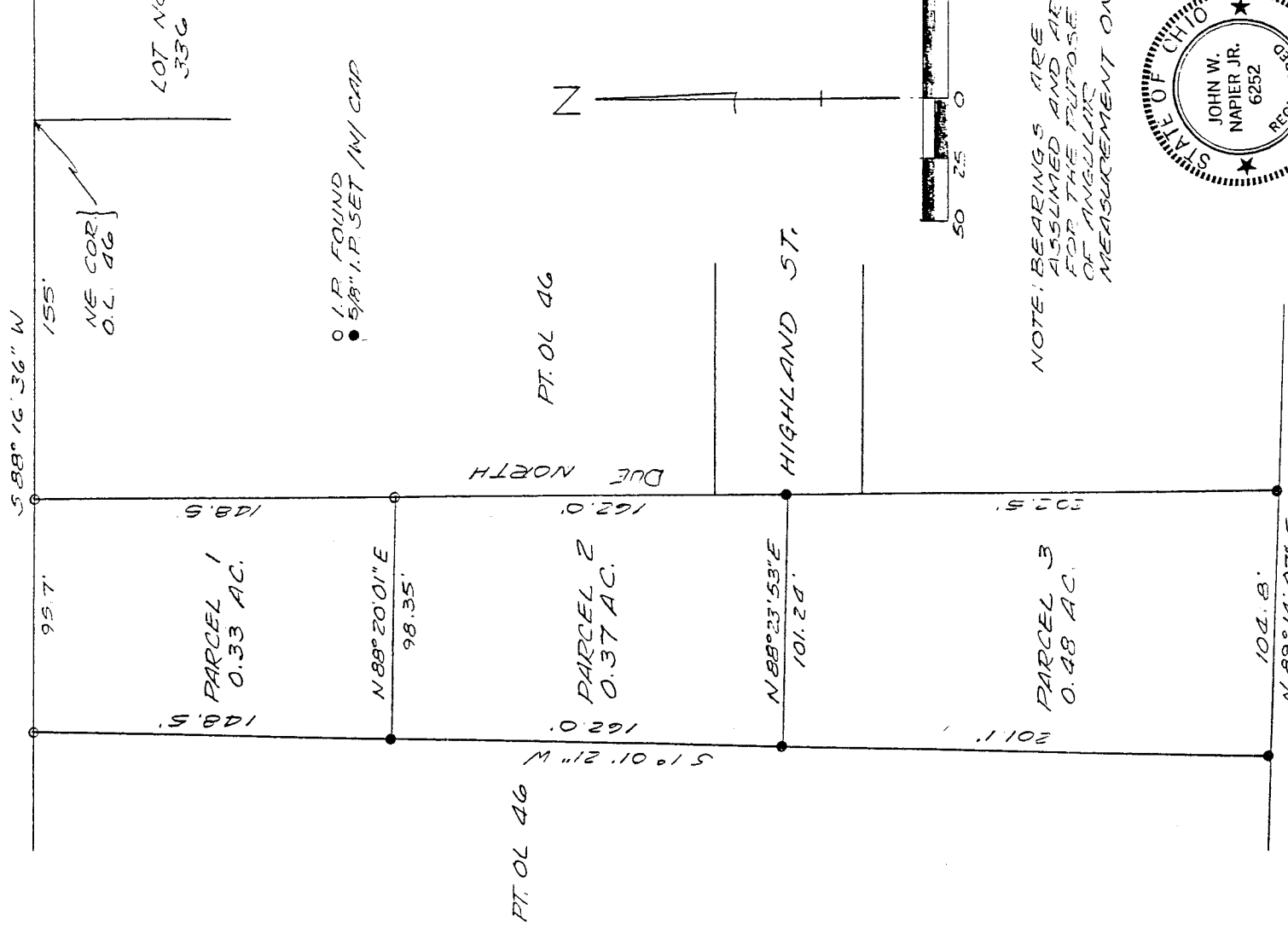
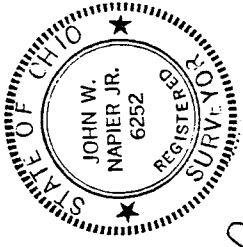

thence N 88° 23' 53" E, a distance of 101.24 feet;


