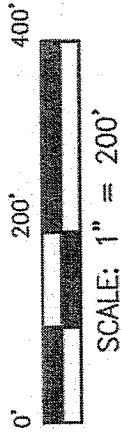
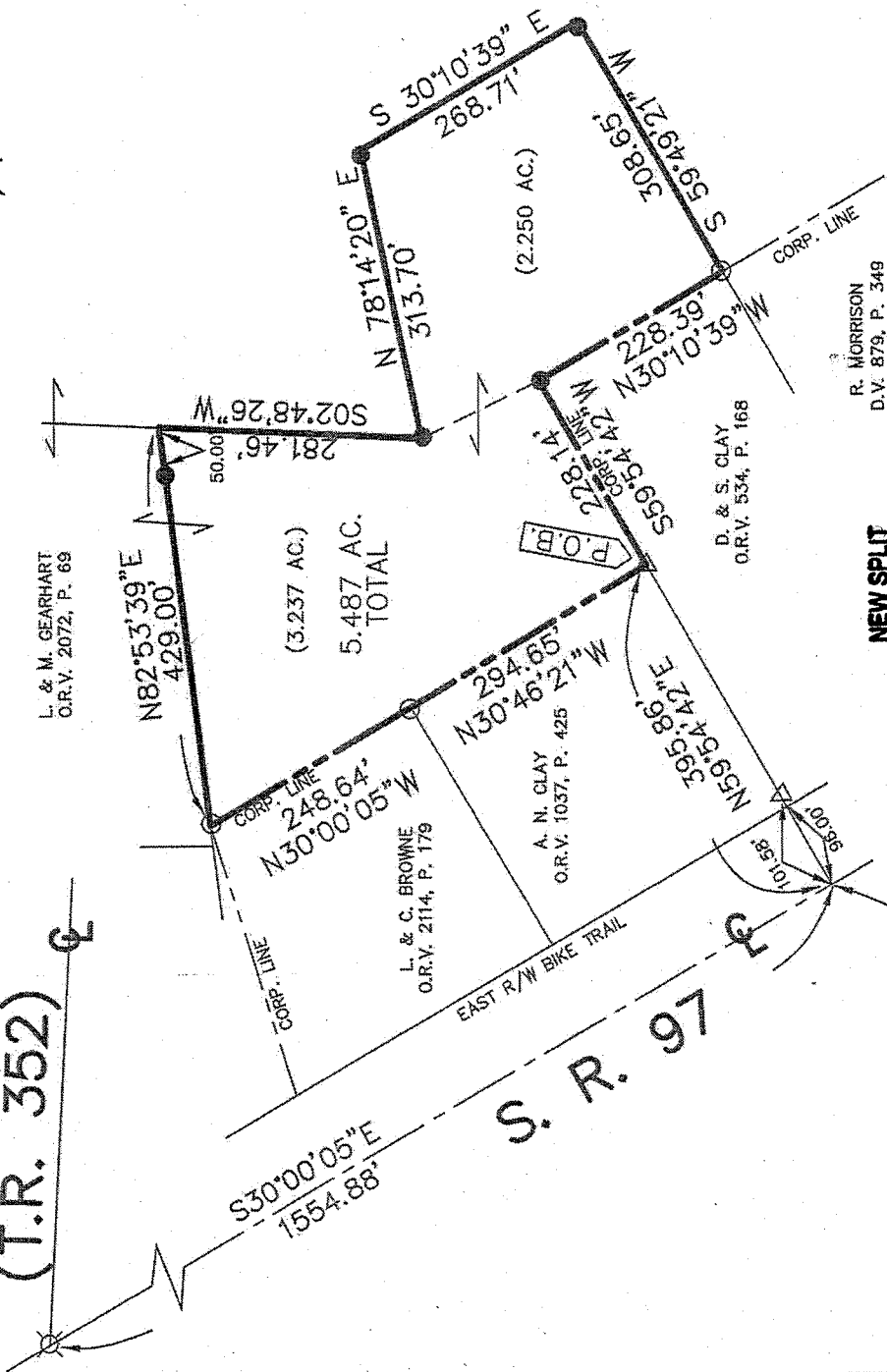


PLAT OF PROPERTY SURVEY

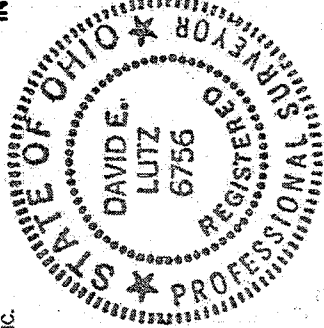

DESCRIPTION

PART OF THE NORTHEAST QUARTER, SECTION FIVE (5),
TOWNSHIP NINETEEN (19), RANGE EIGHTEEN (18),
JEFFERSON TOWNSHIP, RICHLAND COUNTY, OHIO

DESCRIPTION: Being part of the Northeast Quarter, Section Five (5), in Township Nineteen (19), Range Eighteen (18), Jefferson Township, Richland County, Ohio and being more particularly described as follows:

Beginning for the same at a mag. nail found in the intersection of the centerline of Spayde Road (Township Road 352) with the centerline of State Route 97, thence S 30°00'05" E, a distance of 1554.88 feet, along the centerline of State Route 97, to a point, thence N 59°54'42" E, a distance of 395.86 feet, passing a railroad spike found at 101.58 feet, to a railroad spike found, which spike is the real point of beginning of the parcel herein described,

- 1.) thence N 30°46'21" W, a distance of 294.65 feet, to an iron pin found,
- 2.) thence N 30°00'05" W, a distance of 248.64 feet, to an iron pin found,
- 3.) thence N 82°53'39" E, a distance of 429.00 feet, to a point, passing over an iron pin set 50.00 feet westerly thereof,
- 4.) thence S 02°48'26" W, a distance of 281.46 feet, to an iron pin set,
- 5.) thence N 78°14'20" E, a distance of 313.70 feet to an iron pin set,
- 6.) thence S 30°10'39" E, a distance of 268.71 feet to an iron pin set,
- 7.) thence S 59°49'21" W, a distance of 308.65 feet to an iron pin found,
- 8.) thence N 30°10'39" W, a distance of 228.39 feet to an iron pin set,
- 9.) thence S 59°54'42" W, a distance of 228.14 feet to the railroad spike found at the real point of beginning;

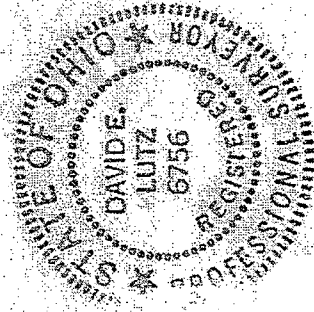
