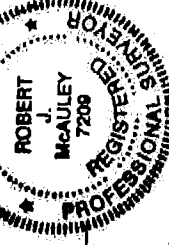

Description Raemelon Farm 2.267 Acre Parcel

Situated in the City of Mansfield, Township of Madison, County of Richland, State of Ohio and being part of the Northwest Quarter of Section 32, Township 21, Range 18, and being a part of a parcel of land now or formerly owned by Raemelon Farm as recorded in Deed Volume 827 Page 28 of the Richland County Recorders records and being more particularly described as follows:

Commencing at a Monument Box found on the centerline of Trimble Road at the southwest corner of the Northwest Quarter of Section 32;

Thence North 89°10'20" East along the south line of the Northwest Quarter of Section 32, a distance of 695.01 feet to a survey marker set on the west line of lands now or formerly owned by Raemelon Farm as recorded in Deed Volume 827, Page 28 and the east line of lands now or formerly owned by Antrim Properties LLC as recorded in Official Record Volume 1295, Page 751 of the Richland County Recorder's records;

Thence North 00°59'07" West along the east line of said Antrim Properties LLC lands, the west line of said Raemelon Farm lands, a distance of 1146.26 feet to a survey marker set at the **Point of Beginning** of the parcel herein described;

- 1) Thence **North 00°59'07" West** along the west line of said Raemelon Farm lands, the east line of said Antrim Properties LLC lands, the east line of lands now or formerly owned by McCready Zupan Holding Company LLC as recorded in Official Record Volume 2087, Page 249 in the Richland County Recorder's records, also the east line of Lot 23309 of Raemelon Farm Antrim Subdivision No. 1, Block A, Replat and Plat Book Volume 32, Page 17 in the Richland County Recorder's records, a distance of **180.04 feet** to a survey marker found at the southwest corner of lands now or formerly owned by New Donegal Properties LLC as recorded in Official Record Volume 1295, Page 748 of the Richland County Recorders records;
- 1) Thence **North 89°02'28" East** along the south line of said New Donegal Properties LLC lands, a distance of **548.85 feet** to a "Craig" survey marker found at the southeast corner of said New Donegal Properties LLC lands and the southwest corner of lands now or formerly owned by Elizabeth A. Brown Living Trust as recorded in Official Record Volume 1957, Page 226, Official Record Volume 2183, Page 849-851 of the Richland County Recorder's records;

- 2) Thence South 00°59'56" East a distance of 179.79 feet to a survey marker set;
- 3) Thence South 89°00'53" West a distance of 548.89 feet to the survey marker set at the Point of Beginning, and containing 2.267 acres of land, more or less, subject to all highways, easements, and use restrictions of record.

The grantees, his heirs and assigns do hereby covenant and agree that the parcel of land described in this instrument or any portion thereof does not constitute a principal building site under applicable zoning and will not be conveyed by said grantees, heirs and assigns independent and separate from any adjoining or contiguous parcel fronting on a public highway or street.

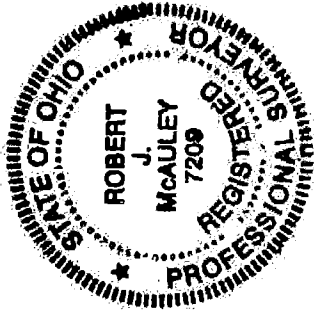
