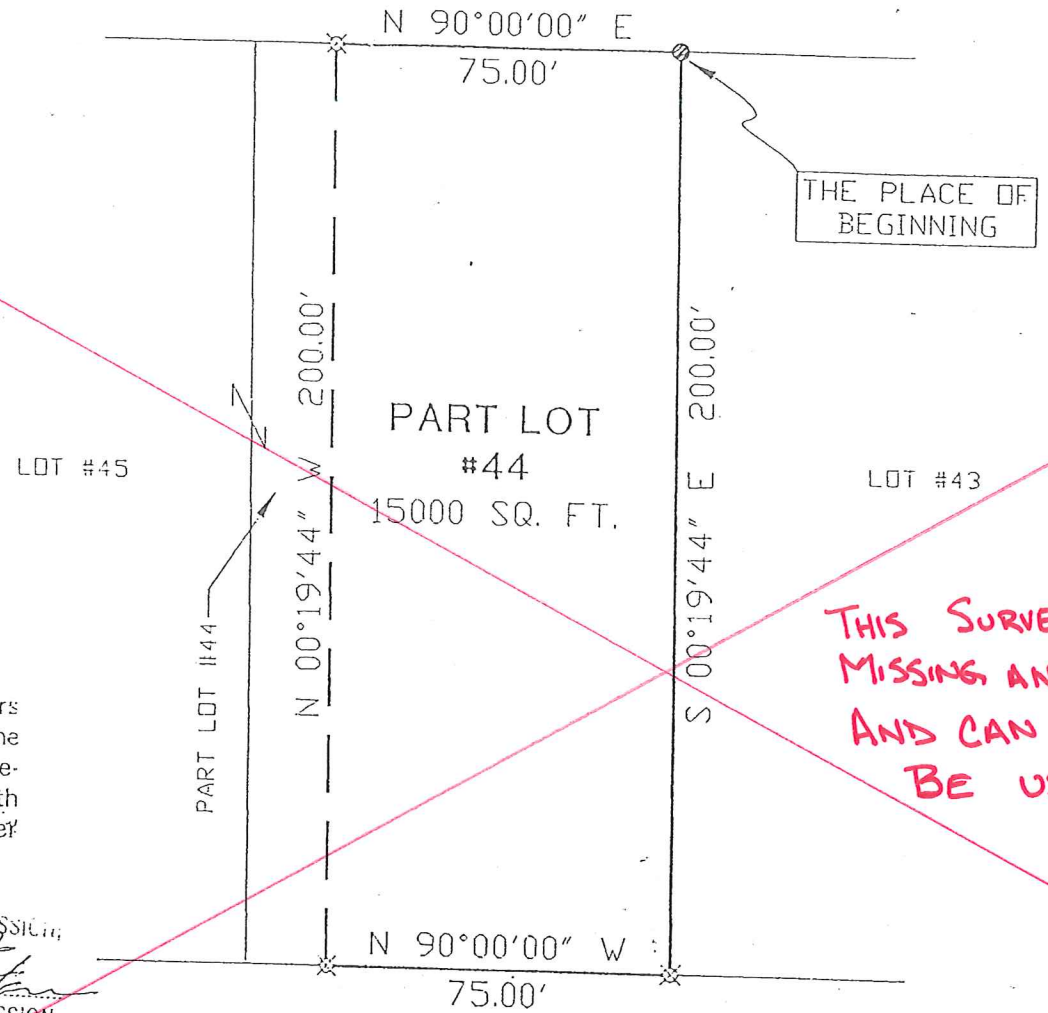

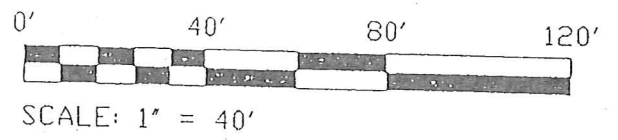
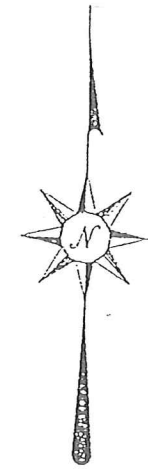

SURVEY DESCRIPTION

PART OF LOT #44
FREDERIC SUBDIVISION

Situated in the Township of Madison, County of Richland, State of Ohio and being a part of Lot #44 in Frederic Subdivision (plat reference: Volume 18, page 112), more particularly described as follows:

Beginning for the same at an iron pin found and accepted as marking the northeast corner of said lot; Thence, South 00 degrees 19 minutes 44 seconds East with the east line of said lot, a distance of 200.00 feet to an iron pin set marking the southeast corner thereof;

Thence, North 90 degrees 00 minutes 00 seconds West with the south line of said lot, a distance of 75.00 feet to an iron pin set;

Thence, North 00 degrees 19 minutes 44 seconds West a distance of 200.00 feet to an iron pin set on the north line of said lot;

Thence, North 90 degrees 00 minutes 00 seconds East with said north line, a distance of 75.00 feet to the place of beginning, containing 15,000 square feet, according to survey by Douglas C. Seiler, Professional Surveyor #6869 on August 28, 1996.

Iron pins set are 5/8" rods with caps stamped "SEILER 6869".

Bearings are based on an assumed meridian and are intended to be used for angular determination only.

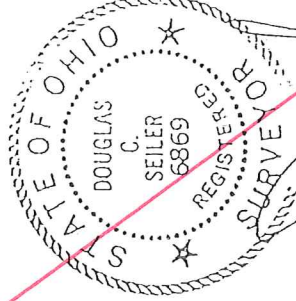
