Situated in the Township of Jackson, County of Richland, State of Ohio and being part of the Northeast Quarter of Section 14, Township 22, Range 19, and being more particularly described as follows:

Commencing at a railroad spike found on the north line of said Northeast Quarter at the intersection of the centerline of Laser Road (T.H. 210) and the centerline of Holtz Road (T.H. 198), said railroad spike also being the northwest corner of a 0.86 acre parcel of land conveyed to John and Inez M. Shepherd by volume 321, page 970 of Richland County official records;

Thence S 01° 40' 00" W, 290.40 feet along said centerline of Laser Road also being along the west line of said land of John and Inez M. Shepherd to a survey spike found in the southwest corner of said land, said survey spike being the true place of beginning;

Thence S 88° 08' 18" E, 1338.54 feet along the south line of numerous parcels to a point being in the east line of said Northeast Quarter, said point also being in the southeast corner of a parcel of land conveyed to Anna M. Simon by volume 819, page 646 of Richland County deed records and passing through iron pins found at 25.00 feet and 1337.64 feet;

Thence S 01° 34' 37" W, 381.72 feet along said east line of said Northeast Quarter to an iron pin set;


Thence N 88° 11' 35" W, 1339.14 feet to a railroad spike set in said centerline of Laser Road and passing through an iron pin set at 1314.14 feet;

Thence N 01° 40' 00" E, 383.00 feet along said centerline of Laser Road to the true place of beginning and containing 11.752 acres, more or less, but subject to all legal highways and easements of record.

Thence S 88° 11' 35" E, 1339.14 feet to an iron pin set in the east line of said Northeast Quarter and passing through an iron pin set at 25.00 feet;

Thence S 01° 34' 37" W, 325.42 feet along said east line of said Northeast Quarter to an iron pin found in the northeast corner of a parcel of land conveyed to The R.P.F. Limited Partnership by official records volume 512, page 115;

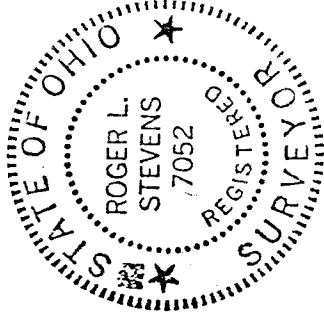
Thence N 88° 10' 30" W, 1339.65 feet along the north line of said land of The R.P.F. Limited Partnership to a P.K. nail found in the northwest corner of said land, said P.K. nail also being in said centerline of Laser Road and passing through an iron pin found at 1314.65 feet;

Thence N 01° 40' 00" E, 325.00 feet along said centerline of Laser Road to the true place of beginning and containing 10.000 acres, more or less, but subject to all legal highways and easements of record.
