

Being a Lot 105 AND THE WEST 17' OF Lot 106, GREEN RIDGE ALLOTMENT #2, NW 1/4, SECTION 25, MADISON TOWNSHIP, RICHLAND COUNTY, OHIO, AND MORE PARTICULARLY DESCRIBED AS FOLLOWS;

BEGINNING AT AN IRON PIN SET AT THE NORTH WEST CORNER OF Lot 105 AS REFERENCED ABOVE;

THENCE N 89° 58' 18" E ALONG AND WITH THE NORTH LINE OF Lot 105, Lot 106 AND THE SOUTH RIGHT OF WAY LINE OF BONNIE DRIVE, A DISTANCE OF 85.00 FEET TO AN IRON PIN SET;

THENCE S 00° 13' 39" E A DISTANCE OF 190.00 FEET TO AN IRON PIN SET ON THE SOUTH LINE OF Lot 106;

THENCE S 89° 58' 18" W ALONG AND WITH THE SOUTH LINES OF Lots 106 AND 105 A DISTANCE OF 85.00 FEET TO AN IRON PIN SET;

THENCE N 00° 13' 39" W ALONG THE WEST LINE OF Lot 105 A DISTANCE OF 190.00' TO THE PLACE OF BEGINNING, AND CONTAINING 16,149.903 SQUARE FEET OF WHICH 12,919.922 SQUARE FEET IS IN Lot 105 AND 3,229.981 SQUARE FEET IS IN THE WEST 17' OF Lot 106, SUBJECT TO ALL EASEMENTS OF RECORD.

This description was prepared from a field survey performed by James K. Cowl, P.S. 6496, on July 21, 1997, the bearings referred to herein are based on an assumed meridian and are for purposes of angular measurement only. The iron pins set are 3/4" diameter rebar with identification caps.
