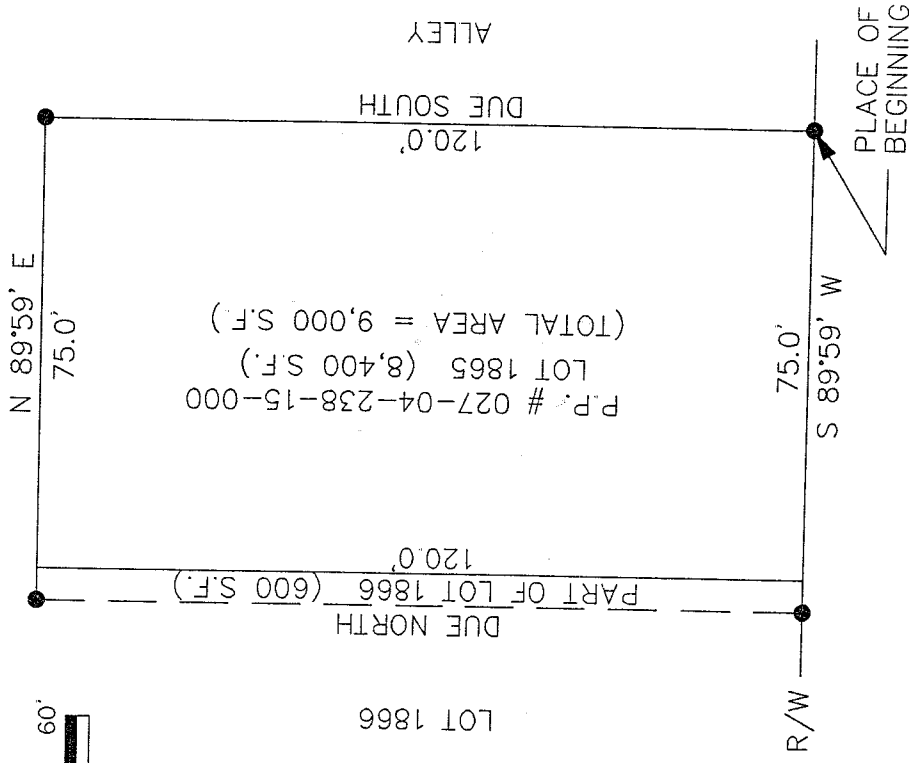

LEGAL DESCRIPTION

LOT 1865 & PART OF LOT 1866
CITY OF MANSFIELD, OHIO

Situated in the City of Mansfield, County of Richland, State of Ohio and being Lot # 1865 and part of Lot # 1866 of the consecutively numbered lots in said City, more particularly described as follows:

Beginning for the same at an iron pin set marking the northwest corner of said Lot # 1865;

Thence, due South with the west line of said lot, a total distance of 120.00 feet to an iron pin set;

Thence, North 89 degrees 59 minutes 00 seconds East along the south line of said lot and its easterly prolongation thereof, a distance of 75.00 feet to an iron pin set;

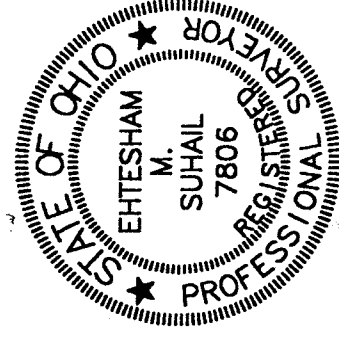
Thence, due North a distance of 120.00 feet to an iron pin set in the north line of Lot # 1866;

Thence, South 89 degrees 59 minutes 00 seconds West along the south line of said lot and its westerly prolongation thereof, a distance of 75.00 feet to the place of beginning, containing 9,000 square feet, according to a survey by Ehtesham M. Suhail, Professional Surveyor # 7806 on September 23, 1997.

Iron pins set are 5/8" rods with caps stamped "SUHAIL 7806".

Bearings are based on an assumed meridian and are intended to be used for angular determination only.
