

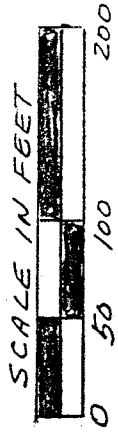

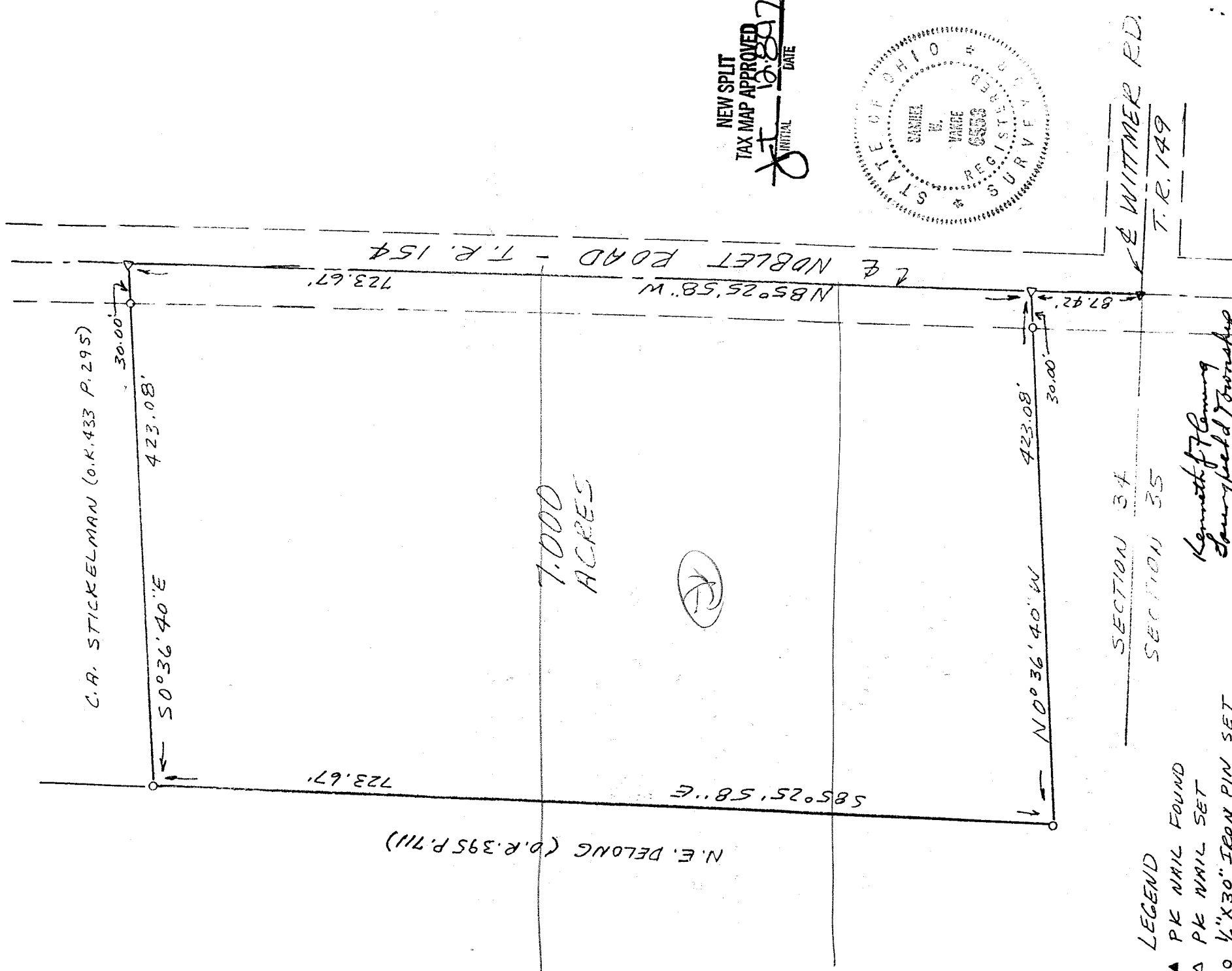
SOUTHWEST QUARTER OF SECTION 34, TOWNSHIP 21, RANGE 19,

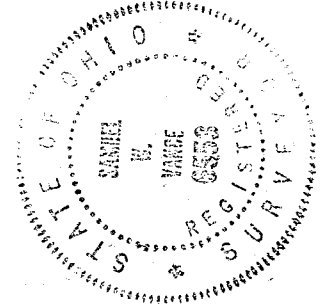

DESCRIPTION - 7.000 ACRE TRACT

Being situated in the southwest quarter of Section thirty-four (34), Township twenty-one (21), Range nineteen (19), Springfield Township, Richland County, State of Ohio and being part of that land of record in Official Records Volume 395, Page 711 in the Richland County Recorder's Office and being more particularly described as follows;

Beginning for reference at a pk nail found in the centerline intersection of Wittmer road (Township Road 149) with Noblet Road (Township Road 154) and being on the west line of Section 34; thence South 85 degrees 25 minutes 58 seconds East along the centerline of Noblet Road a distance of 87.42 feet to a pk nail set and being the true place of beginning;

thence from the true place of beginning North 00 degrees 36 minutes 40 seconds West a distance of 423.08 feet (passing over a 1/2 inch iron pipe set at 30.00 feet) to a 3/4 inch iron pipe set;

thence South 85 degrees 25 minutes 58 seconds East a distance of 723.67 feet to a 1/2 inch iron pin set;

thence South 00 degrees 36 minutes 40 seconds East along the westerly boundary of C.A. Strickelman (O.R. 433 P. 295) a distance of 423.08 feet (passing over a 1/2 inch iron pin set at 393.08 feet) to a pk nail set in the centerline of Noblet Road;

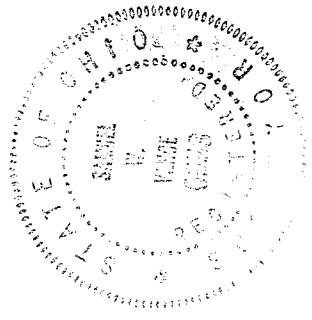
thence North 85 degrees 25 minutes 58 seconds West along the centerline of Noblet Road a distance of 723.67 feet to the place of beginning- containing 7.000 acres, more or less.

Subject to all legal right-of-way of previous record.
