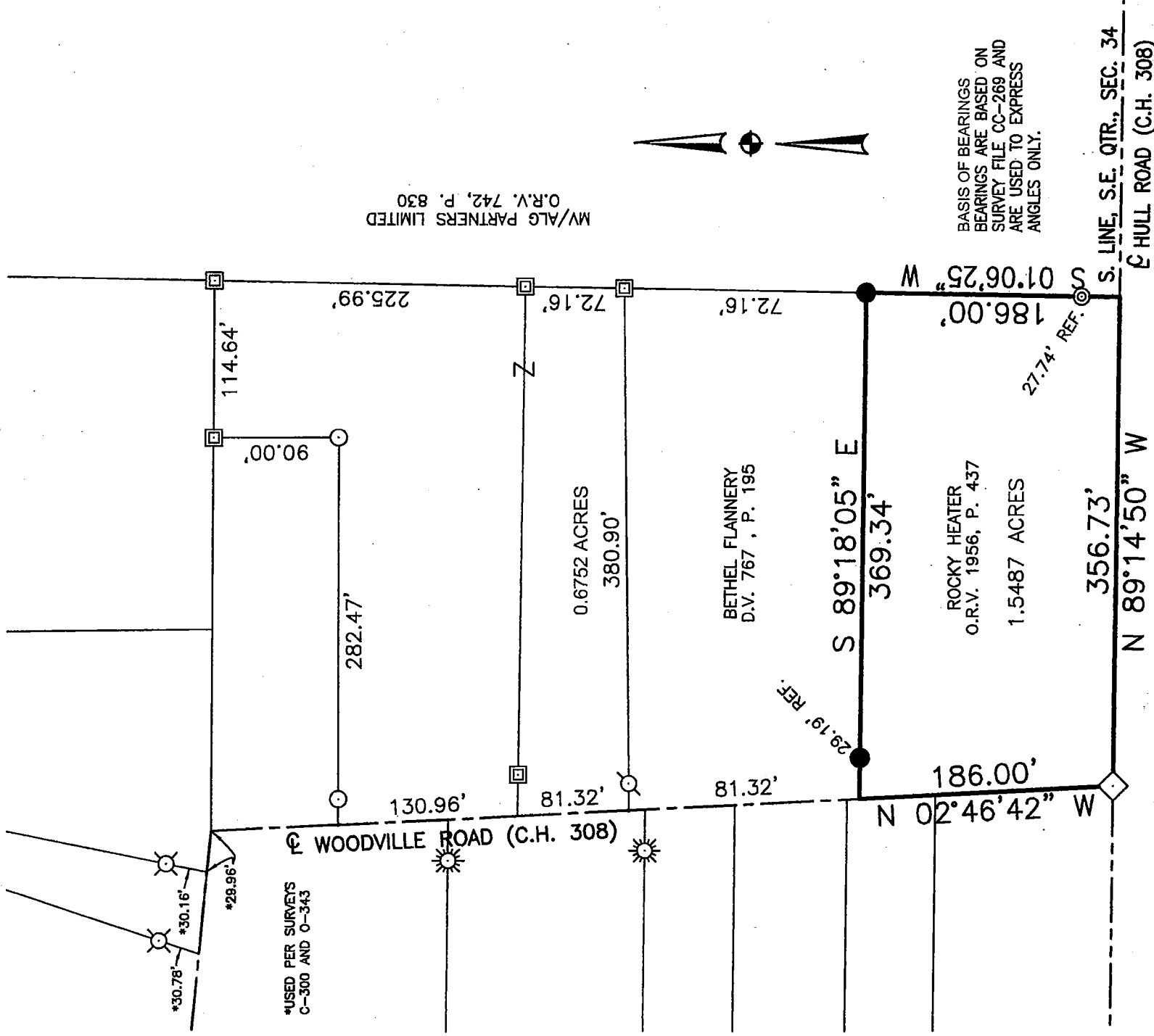


PLAT OF PROPERTY SURVEY FOR

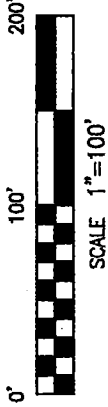

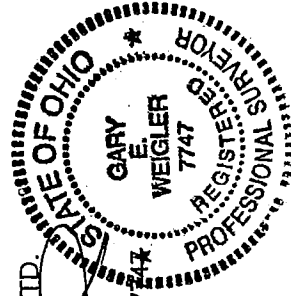

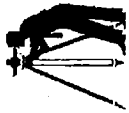

DESCRIPTION
1.5487 ACRE

Situated in the State of Ohio, County of Richland, Township of Madison, being part of the southeast quarter of Section Thirty-four (34) Township Twenty-one (21), Range Eighteen (18), and being a 1.5 acre parcel now or formerly owned by Rocky Heater as recorded in Official Record Volume 1956, Page 437 of the Richland County Recorder's Records and being more particularly described as follows;

BEGINNING at an iron pin with cap stamped "Blunk 6320" found marking the intersection of the centerline of Woodville Road (County Highway 308) and the south line of said quarter, said iron pin also being in the centerline of Hull Road (County Highway 308);

Thence with the following Four (4) courses;

1. **North 02°46'42" West, 186.00 feet** with the centerline of Woodville Road to a point being referenced by a 5/8" rebar set South 89°18'05" East, 29.19 feet, said point also being the southwest corner of a parcel now or formerly owned by Bethel Flannery as recorded in Deed Volume 767, Page 195 of the Richland County Recorder's Records;
2. **South 89°18'05" East, 369.34 feet** with the south line of said Flannery lands to a 5/8" rebar with cap stamped "Weigler 7747" set in the west line of lands now or formerly owned by MV/ALG Partners Limited as recorded in Official Record Volume 742, Page 830 of the Richland County Recorder's Records passing through a 5/8" rebar set for reference at 29.19 feet;
3. **South 01°06'25" West, 186.00 feet** with the west line of said MV/ALG Partners Limited lands to a point in the south line of said quarter and the centerline of said Hull Road, passing through a 1" crimped pipe found at 158.26 feet;
4. **North 89°14'50" West, 356.73 feet** with the south line of said quarter and the centerline of Hull Road, to the point of beginning for the parcel herein described, containing 1.5487 acre, being subject to all legal easements, restrictions and rights-of-way now on record.

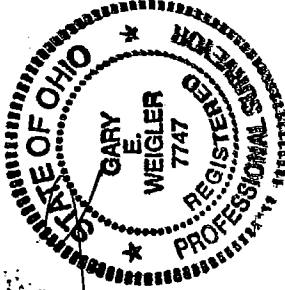
