## WASHINGTON TOWNSHIP, CITY OF MANSFIELD RICHLAND COUNTY, OHIO PART NE QUARTER SECTION 5

Situated in the City of Mansfield, County of Richland, State of Ohio and being a part of the Northeast Quarter of Section 5 Washington Township, and being more particularly described as follows:

Thence, North 88 degrees 31 minutes 21 seconds West with the south line of said quarter a distance of 510.78 feet to a point referenced by an iron pin found on a bearing of North 78 degrees 19 minutes 48 seconds East and at a distance of 1.37 feet, said point also marking the southwest corner of a parcel currently owned by M. & V. Holzmiller (deed reference: O.R.V. 1393, Page 501), the place of beginning of the parcel herein described; Commencing at an iron pin found and accepted as marking the southeast corner of said

Thence, continuing North 88 degrees 31 minutes 21 seconds West with said south line and passing through an iron pin found at a distance of 49.25 feet and passing through an iron pin found at a distance of 202.15 feet, a total distance of 328.57 feet to an iron pin found marking the southeast corner of a parcel currently owned by G. & M. Dalbey (deed reference: O.R.V. 163, Page 81);
