## Parcel 1 92.770 ACRES

The following parcel of land Situated in the State of Ohio, the County of Richland, and the Township of Weller.

Being a portion of a parcel of land conveyed to Mark Lehman by deed recorded in Official Records Volume 2110, Page 0694 (Parcels 2 & 3) and known as being part of the west half of Section 31, T-24-North, R-17-West and being more fully described as follows:

Beginning at a 5/8" rebar with cap "Village Engineering" found at the center of Section 31;

Thence along the following 9 courses:

- 1. South 00°-01'-08" East, along the east line of the southwest quarter of Section 31, a distance of 2132.29 feet to an iron pin set on the north line of a parcel of land conveyed to Ashland Railway Inc. by deed recorded in Official Records Volume 1536, Page 0658;
- 2. Along the north line of said Ashland Railway parcel and a curve to the right a distance of 663.53 feet to an iron pin set, said curve having a chord bearing South 82°-42'-58" West a distance of 661.42 feet, a radius of 2398.70 feet, and a delta angle of 15°-50'-58";
- 3. Along the north line of said Ashland Railway parcel and a curve to the right a distance of 298.25 feet to an iron pin set, said curve having a chord bearing North 88°-36'-36" West a distance of 298.24 feet, a radius of 11402.19 feet, and a delta angle of 01°-29'-55";
- 4. North 87°-51'-38" West, along the north line of said Ashland Railway parcel, a distance of 692.81 feet to a point at the southeast corner of a parcel of land conveyed to Dale R. and Pamela J. Hulit by deed recorded in Official Records Volume 0597, Page 0497, said point being referenced by a ½" rebar with cap "Laughery" found South 00°-01'-42" West a distance of 5.54 feet;
- 5. North 00°-01'-42" East, along the east line of said Hulit parcel, a distance of 2173.43 feet to an iron pin set on the south line of the northwest quarter of Section 31
- 6. North 89°-39'-53" East, along the south line of the northwest quarter of Section 31, a distance of 1248.81 feet to an iron pin set at the southeast corner of a parcel of land conveyed to Mark Lehman by deed recorded in Official Records Volume 2110, Page 0694 (Parcel 1);
- 7. North 00°-48'-29" West, along the east line of said Lehman parcel (Parcel 1), a distance of 1180.40

feet to a point in the center of Pavonia West Road (CR 90), said point being referenced by an iron pin set South 00°-48'-29" East a distance of 32.47 feet;

- 8. South 67°-19'-17" East, along the center of said Pavonia West Road, a distance of 431.76 feet to a point on the east line of the northwest quarter of Section 31, said point being referenced by an iron pin set South 00°-48'-29" East a distance of 32.61 feet;
- 9. South 00°-48'-29" East, along an east line of said northwest quarter, a distance of 1011.60 feet to the place of beginning.

The tract of land as surveyed contains 92.770 acres of land subject to all legal highways and easements of record. Said acreage includes 9.967 acres in the northwest quarter of Section 31 and 82.803 acres in the southwest quarter of Section 31. Being a portion of a parcel of land conveyed to Mark Lehman by deed recorded in Official Records Volume 1018, Page 0767 and known as being part of the east half of Section 31, T-24-North, R-17-West and being more fully described as follows:

Beginning at a 5/8" rebar with cap "Village Engineering" found at the center of Section 31;

- 1. North 00°-48'-29" West, along the east line of the northwest quarter of Section 31, a distance of 1011.60 feet to a point in the center of Pavonia West Road (CR 90), said point being referenced by an iron pin set South 00°-48'-29" East a distance of 32.61 feet;
- 2. South 67°-43'-22" East, along the center of said Pavonia West Road, a distance of 304.17 feet to a point at the northwest corner of a parcel of land conveyed to Cynthia Ann Meeker, Trustee, by deed recorded in Official Records Volume 1497, Page 0067, said corner being referenced by a 5/8" rebar found South 16°-46'-55" West a distance of 30.14 feet;

South 88°-30'-41" East, passing through an iron pin set at a distance of 232.28 feet at the southwest corner of a parcel of land conveyed to Theresia Andreasson by deed recorded in Official Records Volume 1192, Page 0287, thence along the south line of said Andreasson parcel, for a total distance of 568.27 feet to an iron pin set on the west line of a parcel of land conveyed to James A. and Jo Anne Holland by deed recorded in Volume 676, Page 189 of the Richland County Record of Deeds;
- 13. South 14°-00'-41" East, along the west line of said Holland parcel, a distance of 338.19 feet to a point on the south line of the northeast quarter of Section 31, said point being referenced by a 1.5" pipe found South 14°-00'-41" East a distance of 1.33 feet;
- 14. North 89°-59'-04" East, along the south line of the northeast quarter of Section 31, a distance of 43.20 feet to a point at the northwest corner of a parcel of land conveyed to Robert Lamp by deed recorded in Official Records Volume 0414, Page 0889, said point being referenced by a 5/8" rebar with cap "Seiler" found South 00°-11'-50" East a distance of 3.40 feet;
- 15. South 00°-11'-50" East, along the west line of said Lamp parcel, a distance of 968.29 feet to a 5/8" rebar with cap "Seiler" found on the north line of a parcel of land conveyed to Ashland Railway Inc. by deed recorded in Official Records Volume 1536, Page 0658;
- 16. South 46°-31'-09" West, along the north line of said Ashland Railway parcel, a distance of 857.80 feet to an iron pin set;
- 17. Along the north line of said Ashland Railway parcel and a curve to the right a distance of 1183.62 feet to an iron pin set on the east line of the southwest quarter of Section 31, said curve having a chord bearing South 60°-39'-19" West a distance of 1171.65 feet, a radius of 2398.70 feet, and a delta angle of 28°-16'-20";
- 18. North 00°-01'-08" West, along the east line of the southwest quarter of Section 31, a distance of 2132.29 feet to the place of beginning.

The tract of land as surveyed contains 83.749 acres of land subject to all legal highways and easements of record. Said acreage includes 21.145 acres in the northeast quarter of Section 31 and 62.604 acres in the southeast quarter of Section 31. Beginning for reference at a 5/8" rebar with cap "Village Engineering" found at the center of Section 31; Thence North 00°-48'-29" West, along the east line of the northwest quarter of Section 31, a distance of 1011.60 feet to a point in the center of Pavonia West Road (CR 90), said point being referenced by an iron pin set South 00°-48'-29" East a distance of 32.61 feet; Thence South 67°-43'-22" East, along the center of said Pavonia West Road, a distance of 651.06 feet to a point at the northeast corner of a parcel of land conveyed to Cynthia Ann Meeker, Trustee, by deed recorded in Official Records Volume 1497, Page 0067, said corner being referenced by a 5/8" rebar found South 16°-46'-55" West a distance of 30.14 feet; Thence South 69°-41'-46" East, along the center of said Pavonia West Road, a distance of 193.43 feet to a mag nail found; Thence South 75°-46'-30" East, along the center of said Pavonia West Road, a distance of 54.80 feet to a mag nail found; Thence North 89°-48'-54" East, along the center of said Pavonia West Road, passing through a 5/8" rebar found at a distance of 112.79 feet, a total distance of 125.11 feet to a point at the northwest corner of a parcel of land conveyed to Alan R. and Rebecca J.
