

# SURVEYOR'S DESCRIPTION FOR CHARLES MILLER & JUDY GOLDEN

#### 15.619 Acres

Situated in the Township of Jefferson, County of Richland, State of Ohio, being part of the Northwest Quarter of Section 4, Township 19, Range 18 and being more particularly described as follows:

Beginning at a wood fence post found in the southeast corner of said Northwest Quarter;

Thence with the following **FIVE** courses:

- S 89° 35' 58" W, 623.16 feet along the south line of said Northwest Quarter to a point being in the former centerline of Andrews Road, said point being within the Limited Access Right of Way of State Route 13 and passing through an iron pin found at 485.18 feet, said point also being referenced by an iron pin found S 89° 35' 58" W, 33.06 feet from said point;
- Northerly along said former centerline of Andrews Road, now within the Limited 2) Access Right of Way of State Route 13 on a curve to the right having a radius of 1,350.00 feet, an arc length of 559.16 feet, a delta angle of 23° 43' 54", a chord length of 555.17 feet and a chord bearing of N 01° 25' 29" W to an iron pin found in a point of tangency;

Commencing at a wood fence post found in the southeast corner of said Northwest Quarter, said wood fence post also being in the southwest corner of said Northeast Quarter and being in the southwest corner of a parcel of land conveyed to Anthony Mayo by official records volume 966, page 232;

Thence N 00° 13' 36" E, 756.05 feet along the east line of said Northwest Quarter also being along the west line of said Northeast Quarter and the west line of said land of Anthony Mayo to an iron pin found in the northwest corner of said land, said iron pin also being the true place of beginning;

Thence with the following TWELVE courses:

- N 89° 47' 40" E, 281.34 feet along said north line of said Northwest Quarter to the place of beginning, passing through previously referenced iron pin set at 69.367 feet and containing 18.504 acres, more or less, of which 15.580 acres are in the Northeast Quarter of Section 4 and 2.924 acres are in the Northwest Quarter of Section 4 and subject to all legal highways and easements of record.
