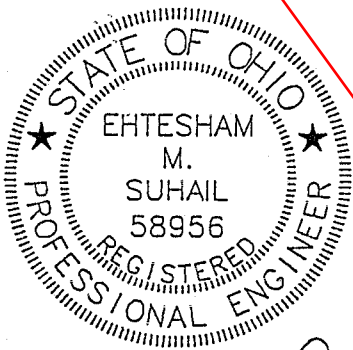
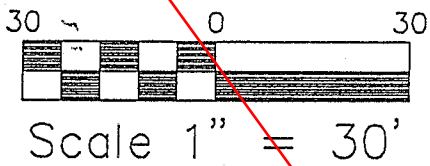

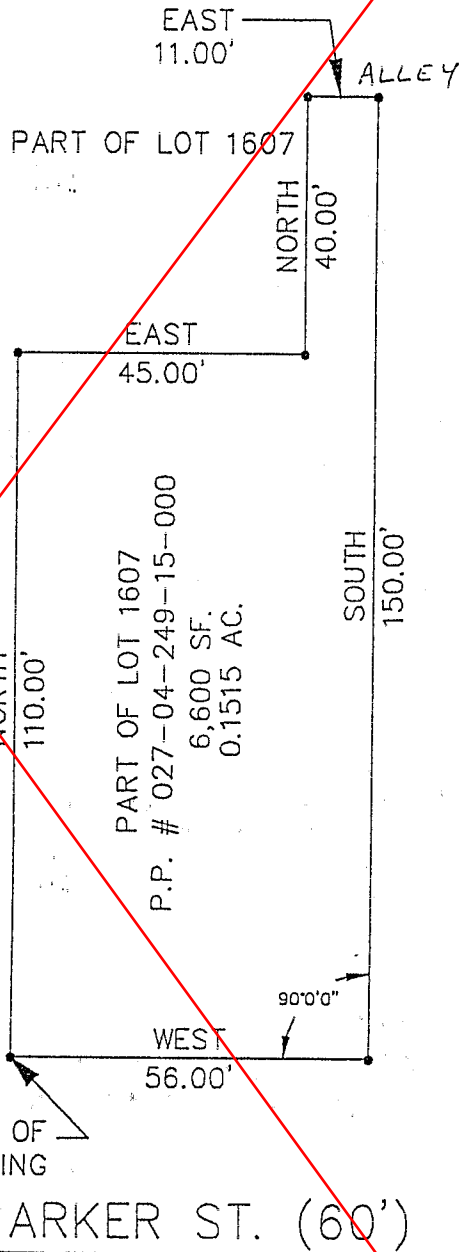

LEGAL DESCRIPTION

PART OF LOT 1607
CITY OF MANSFIELD, OHIO

Situated in the City of Mansfield, County of Richland, State of Ohio and being part of Lot # 1607 of the consecutively numbered lots in said City, more particularly described as follows:

Beginning for the same at an iron pin set marking the southwest corner of said lot;

Thence, due north along the west line of said lot, a distance of 110.00 feet to an iron pin set;

Thence, due east a distance of 45.00 feet to an iron pin set;

Thence, due north a distance of 40.00 feet to an iron pin set in the north line of said lot;

Thence, due east a distance of 11.00 feet to an iron pin set in the east line of said lot;

Thence, due south a distance of 150.00 feet to an iron pin set in the south line of said lot;

Thence, due west along the south line of said lot, a total distance of 56.00 feet to the place of beginning and containing 6,600.00 square feet, according to a survey by Ehtesham M. Suhail, Professional Surveyor # 7806 on June 21, 1999.

Iron pins set are 5/8" rods with caps stamped "SUHAIL 7806".

Bearings are based on an assumed meridian and are intended to be used for angular determination only.
