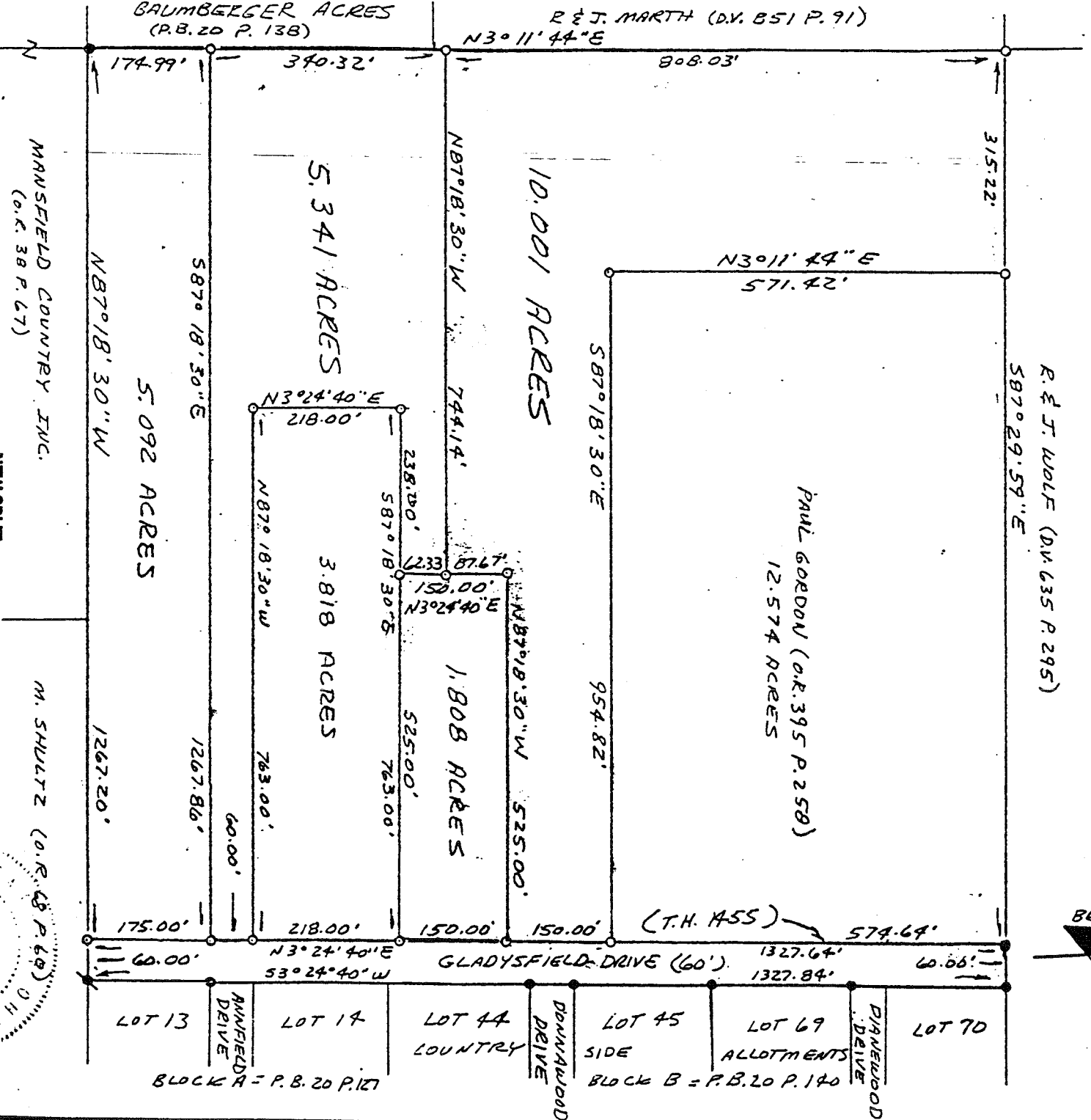

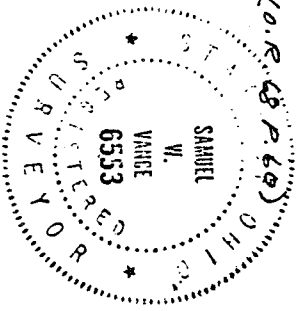

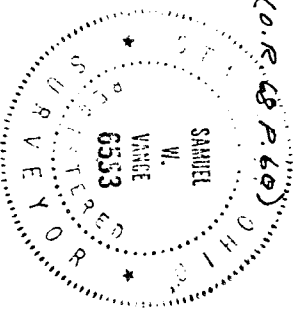

Wolf (D.V. 635 P. 295), a distance of 60.00 feet to an iron pipe found; thence South 03 degrees 24 minutes 40 seconds West along the west line of Gladysfield Drive a distance of 724.64 feet to a 1/2 inch iron pin set and being the true place of beginning;

thence from the true place of beginning South 03 degrees 24 minutes 40 seconds West along the west line of Gladysfield Drive a distance of 150.00 feet to a 1/2 inch iron pins set;

thence North 87 degrees 18 minutes 30 seconds West a distance of 525.00 feet to a 1/2 inch iron pin set;

thence North 03 degrees 24 minutes 40 seconds East a distance of 150.00 feet to a 1/2 inch iron pin set;

thence South 87 degrees 18 minutes 30 seconds East a distance of 525.00 feet to the place of beginning - containing 1.808 acres, more or less.
