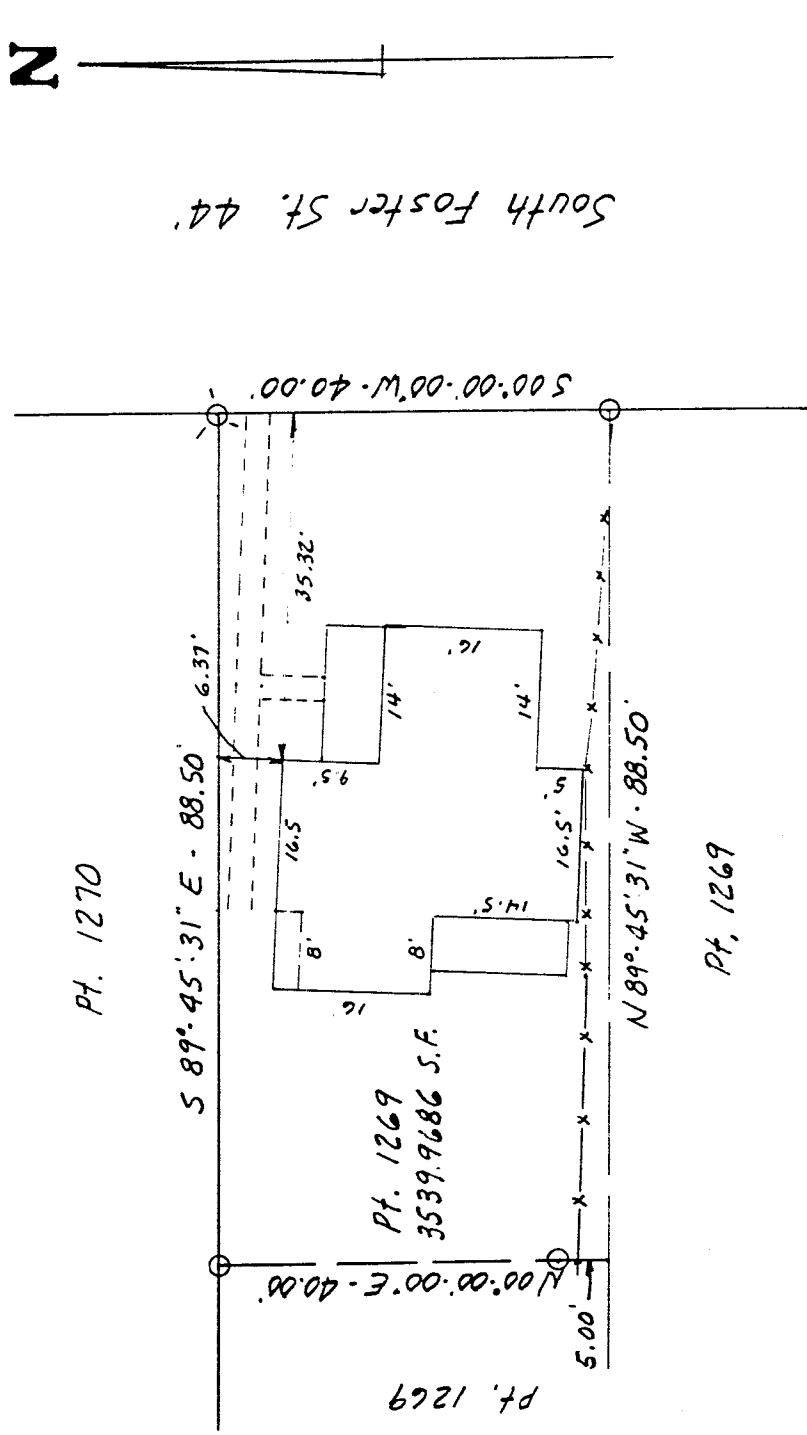

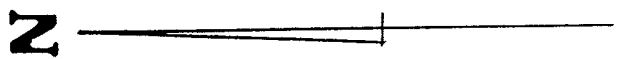

Thence S 00 degrees 00' 00" W along the east line of Lot Number 1269 a distance of 40.00 feet to an iron pin set.

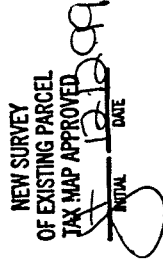
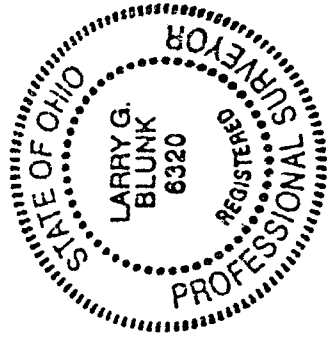
