DESCRIPTION

PART OF THE NORTHWEST QUARTER, SECTION TEN (10) TOWNSHIP TWENTY-ONE (21), RANGE NINETEEN (19) SPRINGFIELD TOWNSHIP, RICHLAND COUNTY, OHIO

DESCRIPTION: Being part of the Northwest Quarter of Section Ten (10), Township Twenty-One (21), Range Nineteen (19), Springfield Township, Richland County, Ohio, and being more particularly described as follows:

Commencing for the same at a railroad spike found at the northwest corner of the Northwest Quarter of Section 10 (southwest corner of the Southwest Quarter of Section 3), said point also being at the intersection of the centerline of Rock Road (C.H. 150) and the centerline of Cookton-Grange Road (T.H. 163); thence S00°10'43"W, along the west line of the Northwest Quarter of Section 10 and the centerline of Rock Road (C.H. 150), a distance of 236.09 feet to the real point of beginning for the parcel herein described, said point being referenced by an iron pin found N85°07'49"E, 30.12 feet;

- 1) thence S84°20'41"E, a distance of 252.99 feet to an iron pin set;
- 2) thence N77°04'11"E, a distance of 329.57 feet to the west line of a 40.53 acre parcel described in Deed Volume 882, Page 514, said point being referenced by an iron pin found S87°44'58"W, 6.82 feet;
- 3) thence S11°28'39"W, continuing along the west line of said 40.53 acre parcel, a distance of 133.23 feet to a corner of said 40.53 acre parcel, said point being referenced by an iron pin found N55°28'44"W, 8.26 feet;
- 4) thence S27°31′50″W, continuing along the west line of said 40.53 acre parcel, a distance of 70.91 feet to the northeast corner of a 2.04 acre parcel described in Official Record Volume 2671, Page 715;
- 5) thence S80°55'21"W, along the north line of said 2.04 acre parcel and passing for reference iron pipes found at 11.02 feet and at 490.85 feet, a total distance of 520.92 feet to the west line of the Northwest Quarter of Section 10 and the centerline of Rock Road;
- 6) thence N00°10'43"E, along the west line of the Northwest Quarter of Section 10 and the centerline of Rock Road, a distance of 226.82 feet to the real point of beginning,

and containing 2.3025 acres, more or less, but subject to all legal easements and public rights-of-way now on record. All iron pins set are 5/8" diameter, 30" long with caps stamped "KROCKA & ASSOC." Bearings are based on survey "KK-11" by F.E. Krocka & Associates, Inc. dated January 4, 2018.
