The portion of the centerline of Richland County Bikeway, having a bearing of N 57°36'55" E, is as designated the "basis of bearings" for this survey.

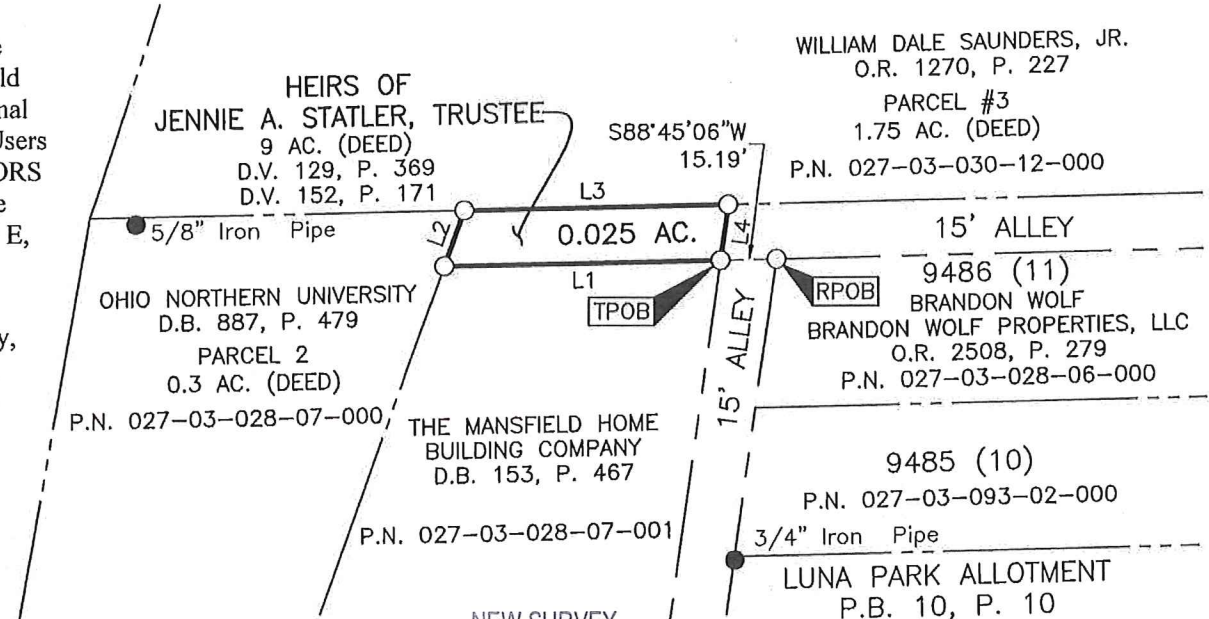

GRAPHIC SCALE (in feet)



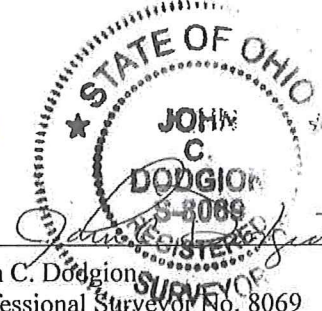

0.025 ACRE

Situated in the State of Ohio, County of Richland, City of Mansfield, lying in the northwest quarter of Section 20, Township 21 North, Range 18 West of the Congress Lands, and being the remainder of the 9 acre tract conveyed to Jennie A. Statler, Trustee by deeds of record in Deed Volume 129, Page 369 and Deed Volume 152, Page 171 (all references are to the records of the Recorder's Office, Richland County, Ohio, unless stated otherwise) and being more particularly described as follows:

Beginning, for reference, at an iron pipe set at the northwesterly corner of Lot 9486 (formerly Lot 11) of the subdivision plat entitled "Luna Park Allotment" of record in Plat Volume 10, Page 10 conveyed to Brandon Wolf and Brandon Wolf Properties, LLC by deed of record in Official Record 2508, Page 279 and the intersection of the southerly right-of-way line of an east-west 15 foot alley with the easterly right-of-way line of a north-south 15 foot alley as shown on said "Luna Park Allotment;"

Thence South 88° 45' 06" West, with the northerly line of said Lot 9486 and said southerly right-of-way line, both extended, a distance of 15.19 feet to an iron pipe set in the westerly right-of-way line of said north-south 15 foot alley and the northeasterly corner of the tract conveyed to The Mansfield Home Building Company by deed of record in Deed Volume 153, Page 467, the TRUE POINT OF BEGINNING;

Thence South 88° 45' 06" West, with said northerly line and said southerly right-of-way line, both extended, a distance of 74.76 feet to an iron pipe set at the northwesterly corner of said Mansfield Home Building tract and in the easterly line of the 0.3 acre tract conveyed as Parcel 2 to Ohio Northern University by deed of record in Deed Volume 887, Page 479;

Thence North 19° 33' 54" East, with said easterly line, a distance of 16.05 feet to an iron pipe set at the northeasterly corner of said 0.3 acre tract and in the southerly line of the 1.75 acre tract conveyed to William Dale Saunders, Jr. by deed of record in Official Record 1270, Page 227;

Thence North 88° 45' 06" East, with said southerly line, a distance of 71.46 feet to an iron pipe set at the intersection of said westerly right-of-way line with the northerly right-of-way line of an east-west 15 foot alley as shown on said "Luna Park Allotment;"

Thence South 07° 52' 27" West, with said westerly right-of-way line, a distance of 15.19 feet to the TRUE POINT OF BEGINNING, containing 0.025 acre, more or less.

Subject, however, to all legal rights-of-way and/or easements, if any, of previous record.

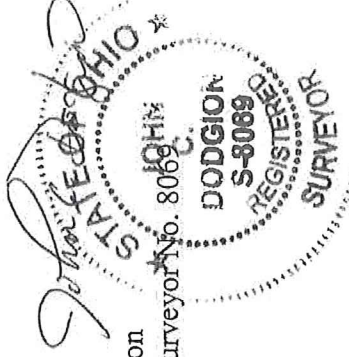
Iron pipes set, where indicated, are thirteen sixteenths (13/16) inch inside diameter, thirty (30) inches long with a plastic plug placed in the top bearing the initials EMHT INC.
