### SURVEY DESCRIPTION

PART OF LOT #9910  
CITY OF MANSFIELD, OHIO

Situated in the City of Mansfield, County of Richland, State of Ohio and being a part of Lot #9910 of the consecutively numbered lots in said city (plat reference: Volume 11, page 8), more particularly described as follows:

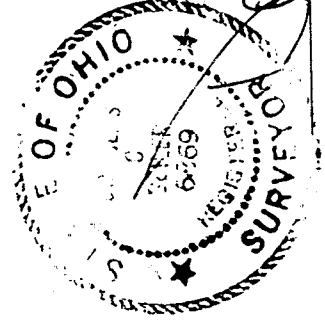
Beginning for the same at an iron pin found and accepted as marking the southwest corner of said lot; Thence, North 15 degrees 14 minutes 47 seconds West with the west line of said lot, passing through an iron pin found at 146.12 feet, a total distance of 146.69 feet to the northwest corner of said lot;

Thence, northeasterly with the north line of said lot, along a curve concave to the south with a central angle of 08 degrees 57 minutes 25 seconds, a radius of 514.00 feet, a chord distance of 80.27 feet with a chord bearing of North 71 degrees 51 minutes 50 seconds East to an iron pin found;

Thence, South 07 degrees 37 minutes 13 seconds East a distance of 167.99 feet to an iron pin found on the south line of said lot;

Thence, South 90 degrees 00 minutes 00 seconds West with said south line, a distance of 60.00 feet to the place of beginning, containing 10958 square feet, according to survey by Douglas C. Seiler, Professional Surveyor #6869 on February 17, 2000.

Bearings are based on an assumed meridian and are intended to be used for angular determination only.
