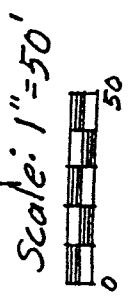
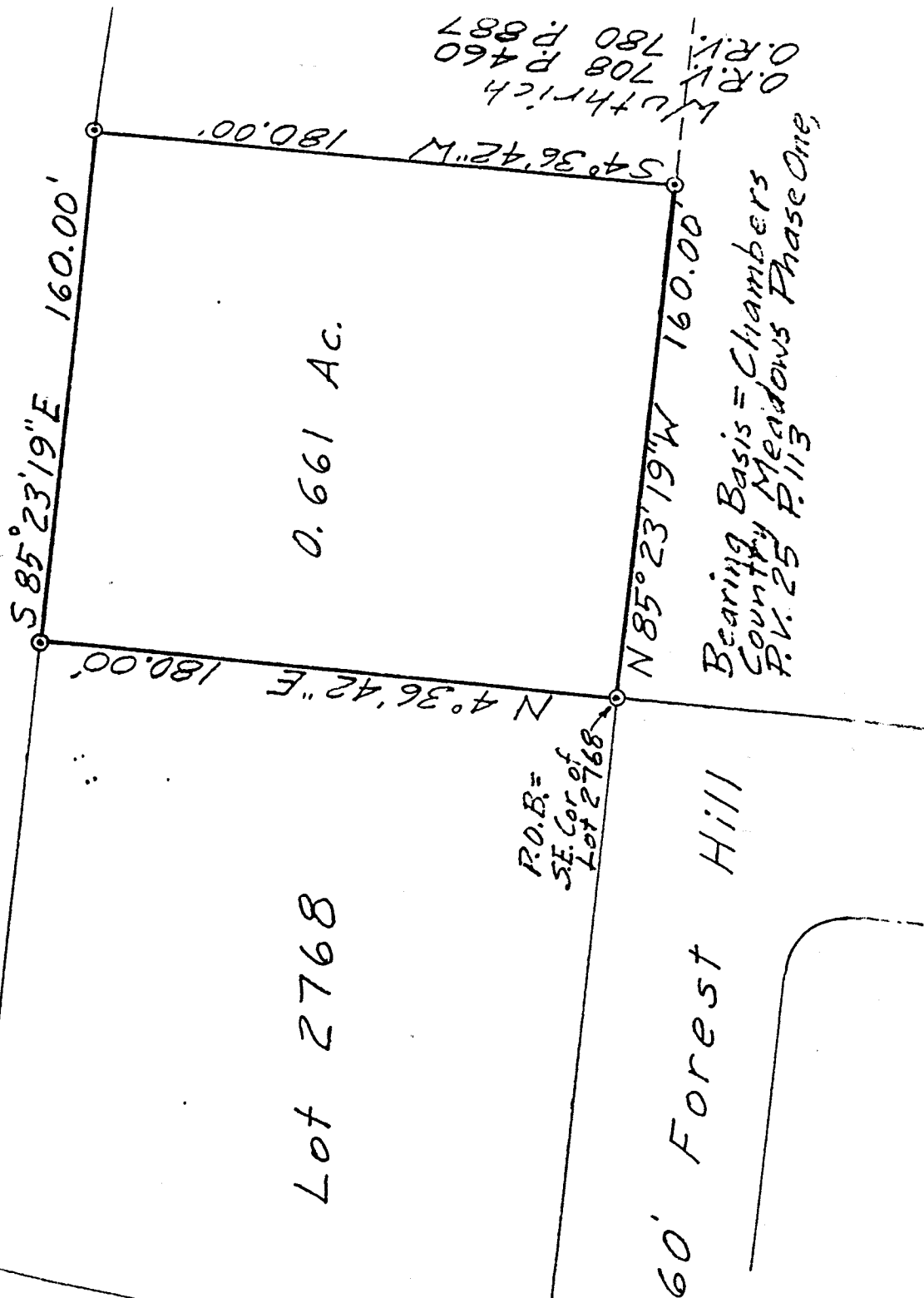

PART OF NE 1/4 SECTION 26
TOWNSHIP 21 RANGE 19
VILLAGE OF ONTARIO
SPRINGFIELD TOWNSHIP
RICHLAND COUNTY, OHIO

Situated in the Township of Springfield, County of Richland, State of Ohio, in the Village of Ontario, and being a part of the Northeast Quarter of Section 26, Township 21, Range 19, and being more particularly described as follows:

Thence South 04° 36' 42" West a distance of 180.00 feet to an iron pin, set and capped;

Thence North 85° 23' 19" West a distance of 160.00 feet to the point of beginning;

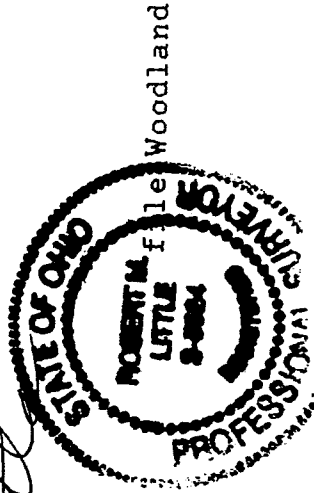
Containing 0.661 acres of land, more or less, but subject to all easements of record.
