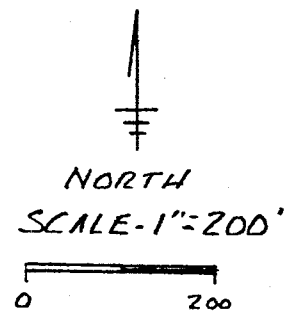


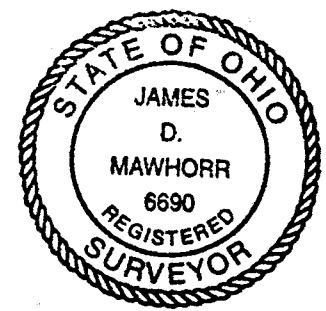

Legal Description
3.729 Acres R & R Radcliffe

Situated in the Township of Weller, County of Richland, State of Ohio, and known as being part of the Southeast Quarter of Section 25, Township 22, Range 18, and more particularly described as follows:

Commencing at a P.K. nail found at the Northeast corner of the Southeast Quarter of Section 25, thence North 87 deg. 18 min. 30 sec. West along the North line of said Quarter Section and the center of Pittenger Road (TH 258) a distance of 1038.93 feet to a P.K. nail found which is the True Place of Beginning;

Thence South 3 deg. 20 min. 36 sec. West along an existing property line, passing thru an Iron pin found at 22.90 feet, a total distance of 687.32 feet to an iron pin set;

Thence North 82 deg. 19 min. 54 sec. West a distance of 240.67 feet to an iron pin set;

Thence North 3 deg. 20 min. 36 sec. East passing thru an iron pin set at 641.44 feet, a total distance of 666.44 feet to a railroad spike set on the North line of the Southeast Quarter of Section 25.

Thence South 87 deg. 18 min. 30 sec. East along said North line and the center of Pittenger Road (TH 258) a distance of 240.00 feet to the True Place of beginning, containing 3.729 acres of land more or less, but subject to all legal highways and easements of record.

Bearings assumed, based on North line, Southeast Quarter Section 25. Iron pins set with caps "Mawhorr 6690".
