

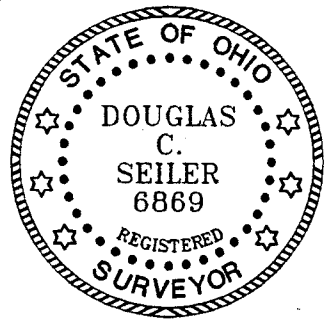

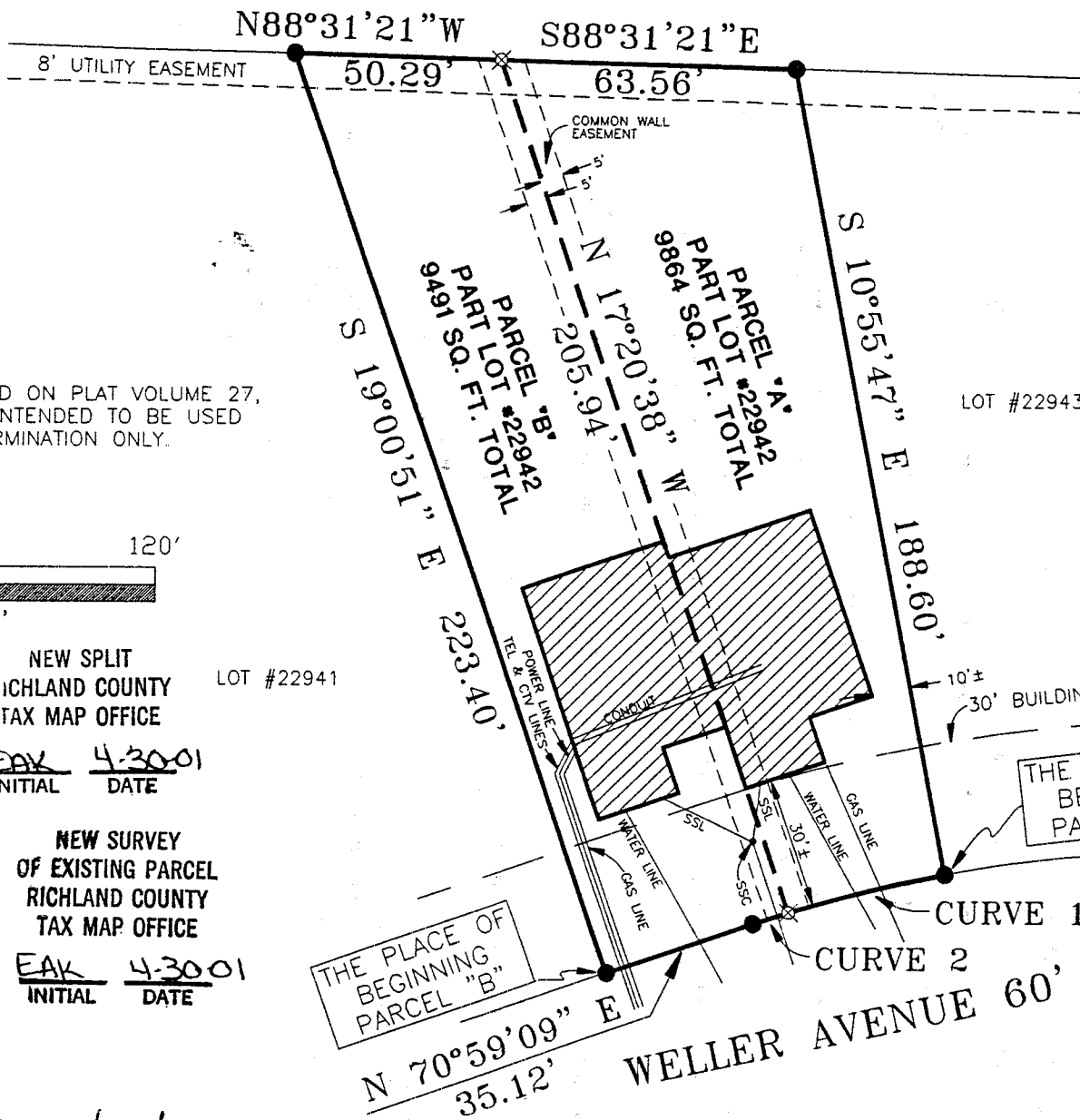

## SURVEY DESCRIPTION

PARCEL "A"

PART OF LOT #22942  
CITY OF MANSFIELD, OHIO

Situated in the City of Mansfield, County of Richland, State of Ohio and being a part of Lot #22942 of the consecutively numbered lots in said city, more particularly described as follows:

Beginning for the same at an iron pin found and accepted as marking the southeast corner of said lot; Thence, southwesterly with the south line of said lot, along a curve concave to the southeast with a central angle of 07 degrees 00 minutes 48 seconds, a radius of 320.00 feet, a chord distance of 39.14 feet with a chord bearing of South 75 degrees 33 minutes 55 seconds West to an iron pin set;

Thence, North 17 degrees 20 minutes 38 seconds West, a distance of 205.94 feet to an iron pin set on the north line of said lot;

Thence, South 88 degrees 31 minutes 21 seconds East with said north line, a distance of 63.56 feet to an iron pin found and accepted as marking the northeast corner thereof;

Thence, South 10 degrees 55 minutes 47 seconds East with the east line of said lot, a distance of 188.60 feet to the place of beginning, containing 9864 square feet, according to survey by Douglas C. Seiler, Professional Surveyor #6869 on April 26, 2001.

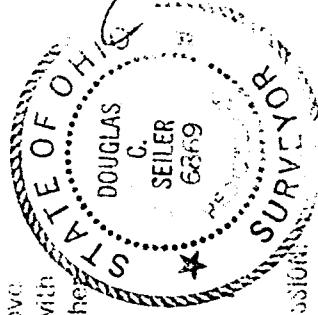
Subject to a 5' wide common wall easement over the westerly five feet of the herein described 9864 square foot parcel, the west line of said easement being the west line of said parcel.

## SURVEY DESCRIPTION

PARCEL "B"

PART OF LOT #22942  
CITY OF MANSFIELD, OHIO

Situated in the City of Mansfield, County of Richland, State of Ohio and being a part of Lot #22942 of the consecutively numbered lots in said city, more particularly described as follows:

Beginning for the same at an iron pin found and accepted as marking the southwest corner of said lot; Thence, North 70 degrees 59 minutes 09 seconds East with the south line of said lot, a distance of 35.12 feet to an iron pin found and accepted as marking a point of curve;

Thence, continuing with said south line, northeasterly along a curve concave to the southeast with a central angle of 01 degrees 04 minutes 17 seconds, a radius of 320.00 feet, a chord distance of 5.98 feet with a chord bearing of North 71 degrees 31 minutes 17 seconds East to an iron pin set;

Thence, North 17 degrees 20 minutes 38 seconds West a distance of 205.94 feet to an iron pin set on the north line of said lot;

Thence, North 88 degrees 31 minutes 21 seconds West with said north line, a distance of 50.29 feet to an iron pin found and accepted as marking the northwest corner of said lot;

Thence, South 19 degrees 00 minutes 51 seconds East, a distance of 223.40 feet to the place of beginning, containing 9491 square feet, according to survey by Douglas C. Seiler, Professional Surveyor #6869 on April 26, 2001.

Subject to a 5' wide common wall easement over the easterly five feet of the herein described 9491 square foot parcel, the east line of said easement being the east line of said parcel.

Together with a 5' wide common wall easement over a strip of land five feet in width, the west line of said easement being the east line of said parcel.

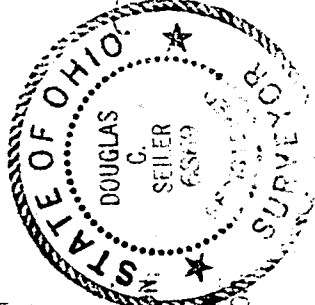
