

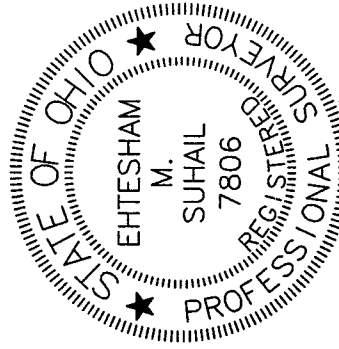
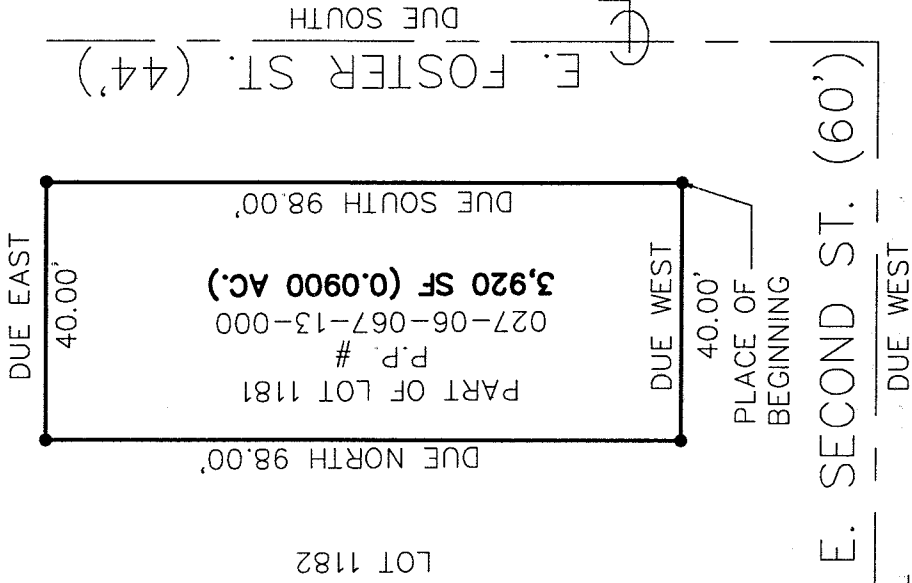

LEGAL DESCRIPTION

PART OF LOT 1181

CITY OF MANSFIELD, OHIO

Situated in the City of Mansfield, County of Richland, State of Ohio and being part of Lot # 1181 of the consecutively numbered lots in said City, more particularly described as follows:

Beginning at the southeasterly corner of Lot 1181, said point being the Place of Beginning of the parcel herein described.

Thence North 90°00'00" West, a distance of 40.00 feet along the northerly line of E. Second Street (60' wide) to the southwesterly corner of Lot 1181, to a drill hole set;

Thence North 00°00'00" West, a distance of 98.00 feet to a drill hole set;

Thence North 90°00'00" East, a distance of 40.00 feet to a drill hole set;

Thence South 00°00'00" East, a distance of 98.00 feet to a drill hole set and also known as the Place of Beginning, containing 3,920 square feet, according to a survey by Ehtesham M. Suhail, Professional Surveyor # 7806 on April 24, 2001.
