

## SURVEYOR'S DESCRIPTION FOR IGNACIO GAYTAN

## 11,059 SQ. FT.

Situated in the City of Mansfield, County of Richland, State of Ohio, being part of Lots 4430 and 4431 of the consecutively numbered Lots in said City and being more particularly described as follows:

**Beginning** at an iron pin set in the northwest corner of said Lot 4431, said iron pin also being in the intersection of the east right of way line of Bowman Street (60') and the south right of way line of Raymond Avenue (50');

Thence with the following SIX courses:

- 1) N 88° 55' 06" E, 205.75 feet along the north line of said Lot 4431, also being along said south right of way line of Raymond Avenue (50') to an iron pin set in a northwest corner of a parcel of land conveyed to Ricky D. and Kimberly L. Minard by official records volume 2358, page 776;
- 2) S 00° 00' 00" W, 60.35 feet along a west line of said land of Ricky D. and Kimberly L. Minard to a point being an interior corner of said land, said point being referenced by an iron pin found, 1 3/4" pipe in concrete, S 00° 00' 00" W, 0.96 feet from said point;
- 3) **S 88° 46' 35" W, 70.72 feet** along a north line of said land of Ricky D. and Kimberly L. Minard to a point being a northwest corner of said land, said point also being in the east line of a parcel of land conveyed to Spankys LLC by official records volume 2424, page 451 and passing through an iron pin found, 1 3/4" pipe in concrete, at 70.40 feet;
- 4) N 00° 00' 00" E, 10.00 feet along said east line of said land of Spankys LLC to a point being the northeast corner of said land, said point also being in the south line of said Lot 4431 and passing through an iron pin found, 1 3/4" pipe in concrete, at 9.29 feet;
- 5) S 89° 08' 33" W, 135.02 feet along said south line of said Lot 4431 to an iron pin found in the southwest corner of said Lot, said iron pin also being in said east right of way line of Bowman Street (60');
- 6) N 00° 00' 00" E, 50.00 feet along the west line of said Lot 4431, also being along said east right of way line of Bowman Street (60') to the place of beginning, and containing 11,059 square feet, more or less, of which 707 square feet are in part of Lot 4430 and 10,352 square feet are in part of Lot 4431, and subject to all legal highways and easements of record.

Bearings are to an assumed meridian and are used to express angles only.

All iron pins set are 5/8" diameter reinforcing rod with plastic cap stamped "STEVENS 7052".
