SURVEY DESCRIPTION, 10,173.586 Sq. Ft.

PART OF OUTLOTS 10 & 11 VILLAGE OF LUCAS, COUNTY OF RICHLAND, STATE OF OHIO

Situated in the Village of Lucas, Township of Monroe, County of Richland, State of Ohio, being a Part of Outlots Ten (10) and Eleven (11) in said Village of Lucas, and being more particularly bounded and described as follows:

Beginning for the same at a Rebar Set at the intersection of the Easterly Right-of-Way Line of Mitchell Drive, and the Northerly Right-of-Way Line of Main Street, thence North 15°~47'~00" West along and with the aforesaid Easterly Right-of-Way Line of Mitchell Drive, a distance of 136.00 feet to a Rebar Set in an existing property corner being the Southwest Corner of Lot 210 in the Green Briar Allotment to the Village of Lucas.

Thence North 79°~35'~30" East along and with an existing property line a distance of 84.00 feet to a Rebar Set in an existing property corner;

Thence South 09°~55'~19" East along and with an existing property line, a distance of 128.00 feet to a Rebar Found in the aforesaid Northerly Right-of-Way Line of Main Street;

Thence South 73°~33'~59" West along and with said Northerly Right-of-Way Line of Main Street, a distance of 70.56 feet to the Place of Beginning.

The foregoing description contains a total of 10,173.586 Square Feet of land more or less, being 602.868 Square Feet situated in aforesaid Part Outlot 10; 9,570.718 Square Feet situated in Part Outlot 11, and being subject to legal highways, easements, and restrictions of record.

All points designated "Rebar Set" have a 5/8 inch diameter epoxy coated rebar in place with a yellow plastic cap bearing the inscription "Jacques Glaze 6817".

The foregoing description was prepared from an actual field survey completed on June 24th, and 25th, 2021 by Jacques M. Glaze, Registered Surveyor #6817, and field assistant Brian J. Gilbert.
