LEGAL DESCRIPTION

Situated in the State of Ohio, County of Richland, Township of Plymouth; being a part of the Northeast Quarter of Section 13, Township 22-North, Range 20-West, and being a portion of lands conveyed to James S. and Tamara L. Whiteside by official record volume 2659, page 480, being more particularly described as follows:

Commencing at a point being the intersection of the centerline of State Route 98-(60' R/W) and the East line of said Quarter referenced by an iron pin found South 79 degrees 58 minutes 37 seconds East, 28.85 feet;

Thence along the centerline of said State Route 98 with a curve to the right having a radius of 1909.86 feet, delta angle of 5 degrees 45 minutes 43 seconds, chord bearing South 43 degrees 46 minutes 46 seconds West and chord distance of 191.98 feet to a point referenced by a concrete monument found North 43 degrees 18 minutes 50 seconds West, 30.00 feet;

Thence, South 46 degrees 41 minutes 10 seconds West, 480.85 feet continuing along said centerline of State Route 98 point of deflection referenced by a concrete monument found North 44 degrees 03 minutes 18 seconds West, 30.00 feet;

Thence South 45 degrees 12 minutes 14 seconds West, 530.38 feet continuing along said centerline of State Route 98 to a 2" Magnail spike set being the Place of Beginning of the parcel described herein;

Thence, the following FOUR Courses:

- 1. **South 45 degrees 12 minutes 14 seconds West, 405.00 feet** continuing along said centerline of State Route 98 to a 2" Magnail spike set in an easterly corner of a parcel conveyed to Walnut Grain Farms, LLC;
- 2. **North 44 degrees 47 minutes 46 seconds West, 430.25 feet** along a northeasterly line of said Walnut Grain Farms, LLC parcel to an iron pin set in an interior corner thereof, passing through an iron pin set for reference at 30.00 feet;
- 3. North 45 degrees 12 minutes 14 seconds East, 405.00 feet along a southeasterly line of said Walnut Grain Farms, LLC parcel to an iron pin set in an interior corner thereof;

4. **South 44 degrees 47 minutes 46 seconds East, 430.25 feet** along a southwesterly line of said Walnut Grain Farms, LLC parcel to the **Place of Beginning**, and passing through an iron pin found for reference at 400.25 feet, containing 4.0003 acres, more or less, and subject to all legal highways, easements, leases, and use restrictions of record.

Bearings are based on an assumed meridian and are used to express angles only.

Iron pins set are 5/8" rebar with plastic cap stamped "Ramsey S-8396"
