#### LEGAL DESCRIPTION

### PARCEL A

**Situated** in the State of Ohio, County of Richland, Township of Jefferson; being a part of the Southwest Quarter of Section 27, Township 19-North, Range 18-West, and being a portion of lands conveyed to Marlin G. Hamilton & Reta A. Hamilton by official record volume 1040, page 242, being more particularly described as follows:

**Beginning** for the same at an iron pin set in the southeast corner of said Southwest Quarter, said iron pin also being on the centerline of Mishey Road-(T.H. 395)(40' R/W) and the **Place of Beginning** of the parcel described herein;

Thence, the following **Twelve** Courses:

- 1. North 89 degrees 53 minutes 22 seconds West, 2460.52 feet along the south line of said Quarter, said centerline of Mishey Road to a point in the southeast corner of a parcel conveyed to Jeffrie D. Jackson by official record volume 1844, page 63;
- 2. **North 00 degrees 44 minutes 43 seconds West, 209.07 feet** along said Jackson parcel to an iron pin found on the south line of a parcel conveyed to David A. Crawford and Mary J. Crawford by official record volume 562, page 180, passing through an iron pin found for reference at 37.98 feet;
- 3. **South 89 degrees 54 minutes 17 seconds East, 54.99 feet** along said south line of Crawford parcel to an iron pin set;
- 4. **North 00 degrees 44 minutes 07 seconds West, 825.00 feet** along the east line of said Crawford parcel to an iron pin set;
- 5. **North 89 degrees 54 minutes 17 seconds West, 264.00 feet** along the north line of said Crawford parcel to an iron pin set on the centerline of Ankneytown Road-(C.H. 116)(R/W 60'), the West line of aforementioned Quarter;
- 6. North 00 degrees 44 minutes 07 seconds West, 415.09 feet along said centerline of Ankneytown Road, said West line to an iron pin set;

- 7. North 89 degrees 05 minutes 22 seconds East, 91.52 feet traversing aforementioned Hamilton parcel to an iron pin set;
- 8. North 82 degrees 48 minutes 54 seconds East, 179.24 feet traversing said Hamilton parcel to an iron pin set;
- 9. North 89 degrees 05 minutes 22 seconds East, 372.73 feet traversing said Hamilton parcel to an iron pin set;
- 10. **North 36 degrees 58 minutes 23 seconds East, 360.75 feet** traversing said Hamilton parcel to an iron pin set on the south line of a parcel conveyed to Carol E. Myers by official record volume 360, page 889;
- 11. North 89 degrees 05 minutes 22 seconds East, 1804.39 feet along said south line of Myers parcel and the south line of a parcel conveyed to Michael F. & Phyllis A. Patterson by official record volume 631, page 26 to an iron pin set on the East line of aforementioned Southwest Quarter;
- 12. **South 00 degrees 47 minutes 45 seconds East, 1800.99 feet** along said East line to the **Place of Beginning**, containing 97.8612 acres, more or less, and subject to all legal highways, easements, leases, and use restrictions of record.

### PARCEL B

**Commencing** at a railroad spike found and accepted as being the northwest corner of said Southwest Quarter, said railroad spike also on the centerline of Ankneytown Road-(C.H. 116)(60' R/W);

Thence South 00 degrees 44 minutes 07 seconds East, 760.24 feet along said centerline of Ankneytown Road to a point in the southwest corner of a parcel conveyed to Wesley G. Good and Lois I. Good by official record volume 2457, page 162, said point also being the Place of Beginning of the parcel described herein;

Thence, the following **SIX** Courses:

- 1. **North 89 degrees 05 minutes 22 seconds East, 863.01 feet** along the south line of said Good parcel and the south line of a parcel conveyed to Carol E. Myers by official record volume 360, page 889 to an iron pin set, passing through an iron pin found for reference at 29.78 feet;
