LEGAL DESCRIPTION

5.536 Acres

Situated in the City of Mansfield, County of Richland, State of Ohio and being part of the Northeast Quarter of Section 5, Madison Township, Township 21 N, Range 18 W and being a portion of the lands conveyed to The City of Mansfield by deed volume 630, page 156 and being more particularly described as follows:

Commencing at an iron pin found in monument box marking the intersection of the centerline of Hecht Road-(T.H. 236) with the North line of said Northeast Quarter of Section 5, said iron pin also being within the right of way of Crall Road-(T.H. 237)(variable R/W);

Thence, **North 89 degrees 26 minutes 09 seconds East, 689.16** feet along the north line of said quarter and said Crall Road to a Magnail spike set in the northeast corner of a parcel conveyed to 37 East Fourth Street, Ltd. by official record volume 2181, page 656 and being the **Place of Beginning** of the parcel herein described;

Thence, the following **SEVEN** Courses:

- 1. North 89 degrees 26 minutes 09 seconds East, 480.13 feet continuing along the north line of said Quarter and said Crall Road to a railroad spike found;
- 2. **South 00 degrees 42 minutes 34 seconds West, 44.60 feet** to a point on the north existing right of way line of Airport West Parkway (PB. 31, Pg. 68), being referenced by an iron pin set South 35 degrees 30 minutes 47 seconds West, 52.56 feet therefrom;
- 3. South 88 degrees 09 minutes 43 seconds West, 71.85 feet along said north existing right of way line of Airport West Parkway to an iron pin set in the northwest corner of said Airport West Parkway;
- 4. Southeasterly along the westerly existing right of way of Airport West Parkway and along a nontangential curve to the right having a radius of 40.00 feet, an arc length of 64.61 feet, a delta angle of 92 degrees 32 minutes, 51 seconds, a tangent length of 41.82 feet, a chord bearing South 45 degrees 33 minutes 51 seconds East, chord distance of 57.81 feet to an iron pin set marking a point of tangency;
- 5. South 00 degrees 42 minutes 34 seconds West, 446.63 feet continuing along the west existing right of way line of Airport West Parkway to an iron pin set;
- 6. South 89 degrees 26 minutes 09 seconds West, 450.12 feet to an iron pin set on the east line of the aforementioned 37 East Fourth Street, Ltd. parcel;
- 7. North 00 degrees 42 minutes 34 seconds East, 533.72 feet along said east line to the Place of Beginning, passing through an iron pin set for reference at 483.71 feet, and containing a total of 5.536 acres, of which 0.536 of an acre is located within the right of

way of Crall Road, resulting in a net area of 5.000 acres, more or less, subject to all legal highways, easements, leases and use restriction of record;

SUBJECT TO an easement for highway purposes reserved by the Grantor and being bounded and described as follows:

Situated in the City of Mansfield, County of Richland, State of Ohio and being part of the Northeast Quarter of Section 5, Madison Township, Township 21 N, Range 18 W and being a portion of the lands conveyed to The City of Mansfield by deed volume 630, page 156 and being more particularly described as follows:

Beginning for the same at a Magnail spike set in the northwest corner of the abovedescribed parcel, the same also being a northeast corner of a parcel conveyed to 37 East Fourth Street, Ltd. by official record volume 2181, page 656 and being on the north line of said Quarter;

Thence, North 89 degrees 26 minutes 09 seconds East, 480.13 feet along the north line of said Quarter to a railroad spike found;

Thence, South 00 degrees 42 minutes 34 seconds West, 44.60 feet to a point on the north existing right of way line of Airport West Parkway, being referenced by an iron pin set South 35 degrees 30 minutes 47 seconds West, 52.56 feet therefrom;

Thence, South 88 degrees 09 minutes 43 seconds West, 243.34 feet along the north existing right of way line of Airport West Parkway and the westerly prolongation thereof to a point;

Thence, South 89 degrees 26 minutes 09 seconds West, 236.97 feet to an iron pin set on the east line of the aforementioned 37 East Fourth Street, Ltd. parcel;

Thence, North 00 degrees 42 minutes 34 seconds East, 50.01 feet along said east line to the **Place of Beginning**, containing 0.536 of an acre, more or less.

Iron pins set are 5/8" rebar with plastic cap stamped "McCartney S-7921"
