

SURVEY DESCRIPTION PARCEL "A"

PART OF THE NW QUARTER OF SECTION 5 TROY TOWNSHIP RICHLAND COUNTY, OHIO

Situated in the Township of Troy, County of Richland, State of Ohio and being a part of the Northwest Quarter of Section 5, of Township 20 North, Range 19 West, and being more particularly described as follows:

Commencing at a Mag Nail spike found and accepted as marking the southeast corner of the northwest quarter of said section the same as being the northeast corner of the southwest quarter of said section and marking a point in the centerline of Bowers Road (T.H. 43), Thence, North 87 degrees 56 minutes 15 seconds West with said quarter section line 30.05 feet to an iron pin found on the west right of way of said road, Thence, North 00 degrees 59 minutes 27 seconds West with said right of way 142.46 feet to an iron pin found, the place of beginning of the parcel herein described;

Thence, North 89 degrees 01 minute 24 seconds West 368.76 feet to an iron pin found:

Thence, South 00 degrees 57 minutes 42 seconds East 135.46 feet to an iron pin found on the south line of said quarter;

Thence, North 87 degrees 56 minutes 15 seconds West with said south line, passing through an iron pin found at 438.03 feet, 1263.07 feet to an iron pin found;

Thence, North 01 degree 22 minutes 11 seconds West, passing through an iron pipe found at a distance of 319.50 feet, a total distance of 530.25 feet to an iron pin found;

Thence, South 87 degrees 36 minutes 52 seconds East 1267.25 feet to an iron pipe found;

Thence, South 00 degrees 57 minutes 42 seconds East 327.38 feet to an iron pipe found;

Thence, South 89 degrees 01 minute 24 seconds East, passing through an iron pipe found at a distance of 368.51 feet, a total distance of 368.73 feet to a point on said right of way;

Thence, South 00 degrees 59 minutes 27 seconds East with said right of way 60.04 feet to the place of beginning, containing a total of 15.77 acres, according to survey by Chad F. Craig P.S. #8195 for Seiler & Craig Surveying, Inc. on July 13, 2021, but subject to all easements and highways of record.

SURVEY DESCRIPTION PARCEL "B"

PART OF THE SW QUARTER OF SECTION 5 TROY TOWNSHIP RICHLAND COUNTY, OHIO

Situated in the Township of Troy, County of Richland, State of Ohio and being a part of the Southwest Quarter of Section 5, of Township 20 North, Range 19 West, and being more particularly described as follows:

Commencing at a Mag Nail spike found and accepted as marking the southeast corner of the northwest quarter of said section the same as being the northeast corner of the southwest quarter of said section and marking a point in the centerline of Bowers Road (T.H. 43), Thence, North 87 degrees 56 minutes 15 seconds West with said quarter section line 30.05 feet to an iron pin found on the west right of way of said road, Thence, South 01 degree 04 minutes 51 seconds East with said right of way, 459.33 feet to an iron pin found, the place of beginning of the parcel herein described;

Thence, South 01 degree 04 minutes 51 seconds East with said right of way 60.04 feet to point referenced by an angle iron found on a bearing of North 89 degrees 02 minutes 27 seconds West and at a distance of 0.54 feet;

Thence, North 89 degrees 02 minutes 27 seconds West passing though said angle iron found, a total distance of 1064.44 feet to an iron pipe found;

Thence, North 86 degrees 27 minutes 46 seconds West 577.16 feet to an iron pipe found;

Thence, North 00 degrees 03 minutes 55 seconds West 524.59 feet to an iron pin found on the north line of said quarter;

Thence, South 87 degrees 56 minutes 15 seconds East with said north line 825.04 feet to an iron pin found;

Thence, South 00 degrees 57 minutes 42 seconds East 474.85 feet to an iron pin found;

Thence, South 89 degrees 02 minutes 27 seconds East 807.44 feet to the place of beginning, containing a total of 11.26 acres, according to survey by Chad F. Craig P.S. #8195 for Seiler & Craig Surveying, Inc. on July 13, 2021, but subject to all easements and highways of record.
