Commencing at a point being the intersection of the centerline of right of way of Mishey Road (T.H. 395)(40') and the centerline of right of way of Garber Road (T.H. 115)(60'), said point also being in the north line of said Northeast Quarter and being referenced by an iron pin found N 52° 49' 15" E, 12.83 feet from said point;

Thence S 18° 06' 56" W, 470.95 feet along said centerline of right of way of Garber Road (T.H. 115)(60') to a point, said point being referenced by an iron pin found S 79° 10' 18" E, 18.58 feet from said point;

Thence S 19° 24′ 44″ W, 132.52 feet and continuing along said centerline of right of way of Garber Road (T.H. 115)(60′) to a point, said point being referenced by an iron pin set N 66° 07′ 16″ W, 22.02 feet from said point and being the **true place of beginning**;

Thence S 18° 06′ 56" W, 470.95 feet along said centerline of right of way of Garber Road (T.H. 115)(60′) to a point, said point being referenced by an iron pin found S 79° 10′ 18" E, 18.58 feet from said point;

Thence S 19° 24′ 44″ W, 298.57 feet and continuing along said centerline of right of way of Garber Road (T.H. 115)(60′) to a point of curve, said point being referenced by an iron pin found N 70° 35′ 16″ W, 15.00 feet from said point;
