

## SURVEYOR'S DESCRIPTION FOR RANDY MCMILLEN

## 15,669 SQ. FT.

Situated in the City of Mansfield, County of Richland, State of Ohio, being part of Lot 20798 and all of Lots 20799 and 20800 of the consecutively number Lots in said City as shown in plat book 11, page 5 and being more particularly described as follows:

**Beginning** at an iron pin set in the southeast corner of said Lot 20800, said iron pin also being in the intersection of the west right of way line of Eight Avenue (60') and the north right of way line of Orange Street (60');

Thence with the following FOUR courses:

- 1) N 89° 27' 45" W, 121.00 feet along said north right of way line of Orange Street (60') also being along the south line of said Lot 20800 to an iron pin found in the southwest corner of said Lot;
- 2) N 00° 00' 00" E, 129.50 feet along the west line of said Lot 20800 and along the west line of said Lots 20799 and 20798 to an iron pin set;
- 3) S 89° 27' 45" E, 121.00 feet to an iron pin set in the east line of said Lot 20798, said iron pin also being in said west right of way line of Eight Avenue (60');
- 4) S 00° 00' 00" W, 129.50 feet along said east line of said Lot 20798 and along the east line of said Lots 20799 and 20800, also being along said west right of way line of Eight Avenue (60') to the place of beginning and containing 15,669 square feet, more or less, of which 3,085 square feet are in part of Lot 20798, 6,292 square feet are in Lot 20799 and 6,292 square feet are in Lot 20800 and subject to all legal highways and easements of record.

- 1) S 00° 00' 00" W, 76.50 feet along said east line of said Lot 20797 and along the east line of said Lot 20798, also being along said west right of way line of Eight Avenue (60') to an iron pin set;
- 2) N 89° 27' 45" W, 121.00 feet to an iron pin set in the west line of said Lot 20798;
- 3) N 00° 00' 00" E, 76.50 feet along said west line of said Lot 20798 and along the west line of said Lot 20797 to a point being the northwest corner of said Lot 20797, said point also being referenced by an iron pin found N 38° 01' 58" E, 1.46 feet from said point;
- 4) S 89° 27' 45" E, 121.00 feet along the north line of said Lot 20797 to the place of beginning and containing 9,257 square feet, more or less, of which 6,172 square feet are in Lot 20797 and 3,085 square feet are in part of Lot 20798 and subject to all legal highways and easements of record.
