Beginning at a R.R. spike found in Poorman Road aka T.H. 415 marking the southeast corner of the southwest quarter of Section 8 the TRUE POINT OF BEGINNING, witnessed by an iron pin set N 00 degrees 18' 49" E 20.89 feet.

thence with the following FIVE (5) COURSES:

- 1) S 89 degrees 33' 05" W 1299.38 feet along the section line and along Poorman Road aka T.H. 415 to a point at the intersection of Poorman Road aka T.H. 415 and Renie Road aka T.H. 117, witnessed by a 5/8 inch rebar found N 46 degrees 57' 15" E 36.05 feet;
- 2) N 00 degrees 11' 07" W 1320.58 feet along the centerline of Renie Road aka T.H. 117 to a point, witnessed by a 5/8 inch rebar found N 89 degrees 44' 15" E 19.50
- 3) N 89 degrees 44' 15" E 651.25 feet along Michael P. Peters' (O.R. 2879 page 833) south line to a 3/4 inch pipe found;
- 4) N 89 degrees 34' 29" E 659.60 feet along Jeffrey L. Roush and Heidi M. Roush's (O.R. 1984 page 610) south line to an iron pin set on the quarter section line;
- 5) S 00 degrees 18' 49" W 1318.30 feet along the quarter section line to the TRUE POINT OF BEGINNING.

- 2) N 89 degrees 34' 29" E 1298.77 feet along Jeffrey L. Roush and Heidi M. Roush's (O.R. 1984 page 610) south line to a 5/8 inch rebar found;
- 3) S 00 degrees 04' 50" W 937.78 feet along Brian N. Wade and Cheryl L. Wade's (O.R. 779 page 453) west line to a R.R. spike found in the center of Poorman Road aka T.H. 415, witnessed by a 5/8 inch rebar found N 00 degrees 04' 50" E 30.00 feet;
