Situated in the State of Ohio, County of Richland, Township of Franklin, being part of the Southeast Quarter of Section Eighteen (18), Township Twenty-two (22), Range Eighteen (18) and being a 6.31 acre parcel now or formerly owned by Charles J. and Julie A. Holloway as recorded in Official Record Volume 2904, Page 297 and being more particularly described as follows;

**Commencing** at a railroad spike found marking the northeast corner of the southeast quarter of Section 18, said railroad spike being in the intersection of Boyce Road (Township Highway 238) and Amoy Ganges Road (County Highway 233);

Thence North 87°40'19" West, 899.31 feet with the north line of said quarter and the centerline of Boyce Road to a point being referenced by a 1/2" iron pipe found South 05°43'48" West, 30.00 feet, said point being the **POINT OF BEGINNING** for the parcel herein described, said point also being the northwest corner of lands now or formerly owned by John K. and Denise McCarron as recorded in Official Record Volume 1000, Page 356;

Thence with the following Six (6) courses;

- 1. South 05°43'48" West, 867.86 feet with the west line of said McCsrron lands to a 1/2" iron pipe found, passing through a 1/2" iron pipe found at 30,00 feet;
- 2. North 89°33'55" West, 396.34' feet to a 5/8" rebar with cap stamped "Weigler 7747" set in the east line of lands now or formerly owned by Jason and Jennifer Meddles as recorded in Official Record Volume 2801, Page 304 of the Richland County Recorder's Records;
- 3. North 03°08'57" East, 666.53 feet with the east line of said Meddles lands to a 5/8" rebar with cap stamped "Weigler 7747" set;
- 4. South 87°40'19" East, 364.61 feet with the south line of a 1 acre parcel now or formerly owned by Charles J. and Julie A. Holloway as recorded in Official Record Volume 2904, Page 297 and lands now or formerly owned by Miranda J. Gallaway as recorded in Official Record Volume 2353, Page 497 to a 1/2" iron pipe found marking the southeast corner of said Gallaway lands;
- 5. North 03°10'05" East, 212.97 feet with the east line of said Gallaway lands to a point in the north line of said quarter and the centerline of Boyce Road, passing through a 1/2" iron pipe found at 182.84 feet;
- 6. South 87°40'19" East, 70.34 feet with the north line of said quarter and centerline of Boyce Road, to the point of beginning for the parcel herein described, containing 6.5400 acre, being subject to all legal easements, restrictions and rights-of-way now on record.

**Commencing** at a railroad spike found marking the northeast corner of the southeast quarter of Section 18, said railroad spike being in the intersection of Boyce Road (Township Highway 238) and Amoy Ganges Road (County Highway 233);

Thence North 87°40'19" West, 1127.21 feet with the north line of said quarter and the centerline of Boyce Road to a point being referenced by a 5/8" Rebar with cap stamped "Weigler 7747" set South 03°10'05" West, 30.00 feet, said point being the **POINT OF BEGINNING** for the parcel herein described, said point also being the northwest corner of lands now or formerly owned by Miranda J. Gallaway as recorded in Official Record Volume 2353, Page 497;

Thence with the following Four (4) courses;

- 1. South 03°10'05" West, 212.97 feet with the west line of said Gallaway lands to a 1/2" iron pipe found, passing through a 5/8" rebar with cap stamped "Weigler 7747" set for reference at 30,00 feet;

- 3. North 03°08'57" East, 212.97 feet with the east line of said Meddles lands to a point in the north line of said quarter and the centerline of Boyce Road, passing through a 1/2" iron pipe found at 181.03 feet;
