

SURVEYOR'S DESCRIPTION FOR JAMES THOMPSON

0.991 Acre

Situated in the Township of Madison, County of Richland, State of Ohio, being part of the Southwest Quarter of Section 24, Township 21, Range 18 and being more particularly described as follows:

Commencing at an iron pin found in the southeast corner of Lot 18 of Pleasant View Ridge Allotment as recorded in plat volume 13, page 15, said iron pin also being in the west line of a parcel of land conveyed to Ohio-American Water Company as recorded in official records volume 769, page 874;

Thence S 00° 54′ 59″ E, 261.65 feet along said west line of said land of Ohio-American Water Company to an iron pin found in the southeast corner of a parcel of land conveyed to Stacy A. and Darrell W. Smith by official records volume 2822, page 198;

Thence S 89° 47′ 31″ W, 175.62 feet along the south line of said land of Stacy A. and Darrell W. Smith to a point and passing through an iron pin found at 160.62 feet;

Thence S 89° 57' 24" W, 216.26 feet and continuing along said south line of said land of Stacy A. and Darrell W. Smith to a point being the southwest corner of said land, said point also being in the centerline of Ridge Road (60') and passing through an iron pin found at 184.72 feet;

Thence N 00° 33′ 19″ W, 23.56 feet along said centerline of Ridge Road (60′) to a point being the southeast corner of a parcel of land conveyed to Gary A. Fisher by official records volume 2895, page 241 said point being referenced by iron pin found S 89° 15′ 02″ W, 28.04 feet from said point and being the **true place of beginning**;

Thence with the following **FOUR** courses:

- S 00° 33' 19" E, 81.01 feet along said centerline of Ridge Road (60') to a point being the northeast corner of a parcel of land conveyed to George D., Jr. and Regina R. Rinehart by official records volume 278, page 572;
- S 88° 56' 24" W, 524.29 feet along the north line of said land of George D., Jr. and Regina R. Rinehart to an iron pin found in the northwest corner of said land, said iron pin also being in the east line of a parcel of land conveyed to Ken Ludwig by official records volume 1978, page 361;
- 3) N 00° 02' 37" E, 83.86 feet along said east line of said land of Ken Ludwig to an iron pin found in the southwest corner of said land of Gary A. Fisher;
- 4) N 89° 15' 02" E, 523.40 feet along the south line of said land of Gary A. Fisher to the **true place of beginning**, passing through previously referenced iron pin found at 495.36 feet and containing 0.991 acre, more or less, and subject to all legal highways and easements of record.
