- 1) **N 70° 16' 30" E, 131.17 feet** to an iron pin set in the westerly line of a parcel of land conveyed to Boe M. and Rachel M. Amos by official records volume 2241, page 421;
- 2) **S 19° 16' 49" E, 49.93 feet** along said westerly line of said land of Boe M. and Rachel M. Amos to a point being the southwesterly corner of said land, said point being in the northerly line of a vacated alley (20') and being referenced by an iron pin found N 88° 49' 50" W, 0.83 feet from said point;
- N 88° 49' 50" W, 139.99 feet along said northerly line of said vacated alley (20') and along the north line of said Lot 622 to the place of beginning, passing through previously referenced iron pin found at 0.83 feet and containing 3,247 square feet, more or less, but subject to all legal highways and easements of record.
