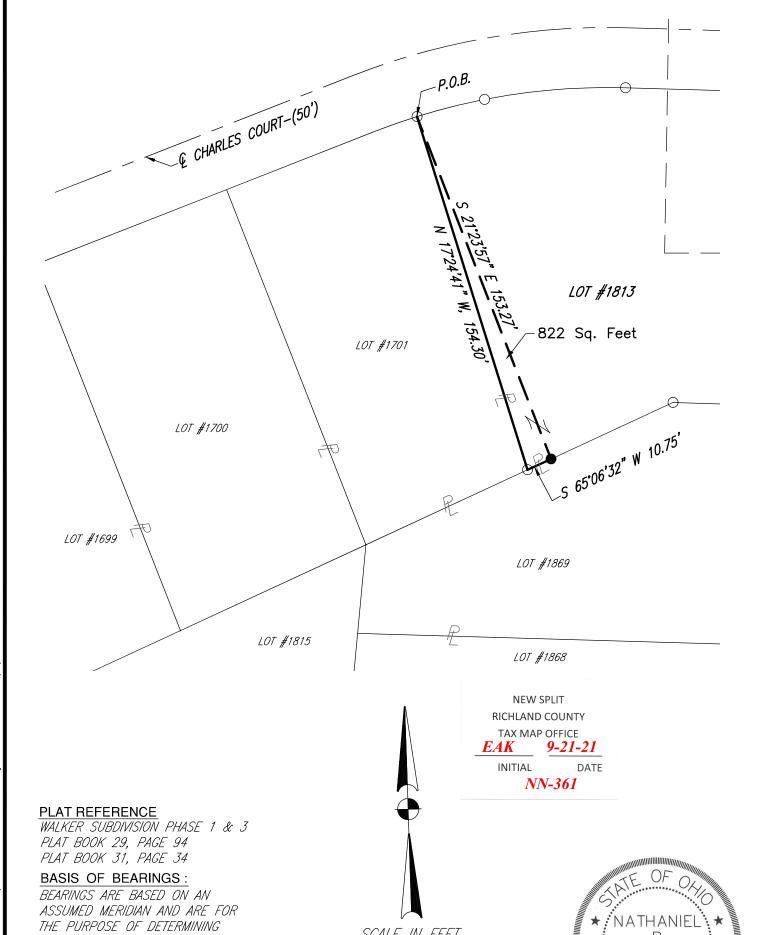

**Situated** in the Village of Lexington, County of Richland, State of Ohio and being a part of Lot #1813 in Walker Subdivision Phase 3 as recorded in Plat Book 31, Page 34 of the Richland County Recorders Records, being more particularly described as follows:

**Beginning** for the same at an iron pin found and accepted as marking the northwest corner of Lot #1813 and being on the south existing right of way line of Charles Court-(50' R/W);

Thence, the following **Three** Courses:

- 1. **South 21 degrees 23 minutes 57 seconds East, 153.27 feet** traversing said Lot #1813 to an iron pin set on a south line thereof;
- 2. **South 65 degrees 06 minutes 32 seconds West, 10.75 feet** along said south line to an iron pin found in the southwest corner of aforementioned Lot #1813;
- 3. **North 17 degrees 24 minutes 41 seconds West, 154.30 feet** along the west line of said Lot #1813 to the **Place of Beginning** and containing 822 sq. ft., more or less, and subject to all legal highways, easements, leases and use restriction of record.

Iron pins set are 5/8" rebar with plastic cap stamped "McCartney S-7921"
