

SURVEYOR'S DESCRIPTION FOR DALE PORE

26.878 acres

Situated in the Township of Worthington, County of Richland, State of Ohio, being part of the Northwest Quarter of Section 33, Township 21, Range 17, and being more particularly described as follows:

Beginning at a railroad spike found in the intersection of the centerline of Hill Road (T.H. 111)(60') and the south line of said Northwest Quarter, said railroad spike being referenced by an iron pin found N 89° 16' 02" E, 20.00 feet from said point;

Thence with the following TWELVE courses:

- 1) **S 89° 16' 02" W, 1,100.13'** along said south line of said Northwest Quarter to an iron pin found in the southeast corner of a 3 acre parcel of land conveyed to Dale Leroy Pore by official records volume 2362, page 692;
- N 02° 04' 21" W, 1,338.38 feet along the east line of said land of Dale Leroy Pore and along the east line of a parcel of land conveyed to Francis E. Kinnane by official records volume 2428, page 335 to an iron pin found in the northeast corner of said land of Francis E. Kinnane, said iron pin also being in the south line of a parcel of land conveyed to Peter Herbert Lawrence by deed volume 605, page 320 and passing through an iron pin found at 379.30 feet;
- N 89° 17' 33" E, 798.74 feet along said south line of said land of Peter Herbert Lawrence to an iron pin found;
- 4) S 21° 35' 59" W, 254.55 feet to an iron pin found in the northerly corner of a parcel of land conveyed to Brian R. and Olivia L. Swank by official records volume 2686, page 420;
- 5) **S 50° 58' 15" W, 292.62 feet** along the northwesterly line of said land of Brian R. and Olivia L. Swank to an iron pin found in the northwesterly corner of said land;
- 6) **S 11° 12' 16" E, 369.52 feet** along the westerly line of said land of Brian R. and Olivia L. Swank to an iron found in the southwesterly corner of said land;
- 7) **N 89° 20' 07" E, 362.26 feet** along the south line of said land of Brian R. and Olivia L. Swank to an iron pin found in the southeasterly corner of said land;
- 8) N 12° 24' 43" E, 230.97 feet along the easterly line of said land of Brian R. and Olivia L. Swank to an iron pin found in an interior corner of said land;
- 9) **S 64° 06' 10" E, 250.80 feet** along the southwesterly line of said land of Brian R. and Olivia L. Swank to an iron pin found in an interior corner of said land;
- 10) **S 36° 35' 46" E, 198.67 feet** and continuing along said southwesterly line of said land of Brian R. and Olivia L. Swank to a point being the southwesterly corner of said land, said point also being in said centerline of Hill Road (T.H. 111)(60') and passing through an iron pin found at 168.67 feet;
- 11) **S 18° 31' 59" W, 389.38 feet** along said centerline of Hill Road (T.H. 111)(60') to a point of curve, said point being referenced by an iron pin found N 80° 41' 14" E, 16.95 feet from said point;

Southwesterly and continuing along said centerline of Hill Road (T.H. 111)(60') on a curve to the left having a radius of 782.00 feet, an arc length of 145.47 feet, a delta angle of 10° 39' 30", a chord length of 145.26 feet and a chord bearing of S 13° 12' 14" W to the place of beginning and containing 26.878 acres, more or less, and subject to all legal highways and easements of record.
